1. Approval of the Amended Recognized Obligation Payment Schedule (ROPS 20-21B) for the National City Successor Agency for the Period of January 1, 2021 – June 30, 2021

Janel Pehau, Finance Analyst for Department of Finance, National City Successor Agency, provided a brief overview to this body regarding the Amended Recognized Obligation Payment Schedule (ROPS) for the second half of Fiscal Year 2020-21 (Amended ROPS 20-21B). The Amended ROPS 20-21B reflects an additional \$500,000 in funds authorized but unspent from ROPS 19-20 to be carried over to the current period for specified items. Brian Hagerty further explained the practice of reflecting unused funds on the ROPS document in the subsequent year.

2. Approval of the Amended Recognized Obligation Payment Schedule (ROPS 20-21B) for the Solana Beach Successor Agency for the Period of January 1, 2021 – June 30, 2021

Rod Greek, Interim Finance Director for Solana Beach Successor Agency, provided a brief overview to this body regarding the Amended Recognized Obligation Payment Schedule (ROPS) for the period January 1, 2021 to June 30, 2021 (Amended ROPS 20-21B). The Amendment is necessary for the payment of approved enforceable obligations (EOs) during the second half of the ROPS. There is no change in EO amount being requested. There is less Reserve balance available for FY 20-21 due to a prior period adjustment for 2018 by Department of Finance (DOF). The Amendment will allow additional funds to be available for Successor Agency (SA) cash flow purposes. This Amendment is requesting that the Reserves reported on the ROPS 20-21B for the period January 2021 to June 2021 of \$44,450 be reduced to zero. The revision results in an increase of \$44,450 in RPTTF being requested.

3. Approval of FY 2020-2021 Special Liability Insurance Program (SLIP) Policy Proposal

Brian Hagerty, County of San Diego Financial Policy & Planning Director, presented to this body regarding the FY 2020-21 Special Liability Insurance Program (SLIP) renewal insurance proposal received from Alliant Insurance Services, Inc. The purpose of the coverage is to

protect Oversight Board (OB) members from potential legal actions arising from their decisions as members of the OB. The annual premium and applicable fees total \$7,103.19, effective 9/29/20 to 9/29/21. The FY 2020-21 SLIP Policy Renewal coverage amount is for personal injury and public officials errors and omissions of \$7,000,000 per occurrence and the coverage amount for fire damages is \$1,000,000 per occurrence. In light of the pandemic, Alliant Insurance Services, Inc. is adding a Pathogen exclusion to the policy. Many carriers have been adding this sort of exclusion to their policies, so this is not unusual. Otherwise, the FY 2020-21 SLIP Policy coverage remains essentially the same as the last two years.
