Title: FirstNet Mobility Resource Units (RU) Fee Revision

Summary:

In accordance with the provisions of the IT and Telecommunications Service Agreement by and between the County of San Diego (“County”) and Peraton Enterprise Solutions LLC (“Contractor” and hereinafter collectively referred to as “the Parties”) with the effective date November 15, 2016 (“the Agreement”), agreement is reached on the effective date shown below.

Issue or Problem:

Contractor provides FirstNet Mobility Services and FirstNet Mobility Services – Tethered, with pricing as follows:

- FirstNet Mobility Services: \$38.31 if total volume for the month is 999 or less; \$33.06 if total volume for the month is 1000 or more.
- FirstNet Mobility Services – Tethered: \$43.68 if total volume for the month is 999 or less; \$38.43 if total volume for the month is 1000 or more.

Contractor has elected to replace banded pricing with a single RU fee for both RUs to address the changing County’s needs.

Resolution:

1. The Parties agree to eliminate banded pricing for FirstNet Mobility Services and replace with single monthly RU Fee of \$33.06 effective December 2025.
2. The Parties agree to eliminate banded pricing for FirstNet Mobility Services - Tethered and replace with single monthly RU Fee of \$38.43 effective December 2025.
3. Schedules 16.1-6 and 16.1-6a are amended to reflect the reduction of FirstNet Mobility Services and FirstNet Mobility Services RU Fees, as per Attachment 1 and 2 to this PRR.

The resolution of the issue or problem as described in this Problem Resolution Report shall govern the Parties’ actions under the Agreement until a formal amendment of the Agreement is implemented in accordance with the terms of the Agreement, at which time this Problem Resolution Report shall be deemed superseded and shall be null and void.
