## COMPACT MOBILE FOOD OPERATION HOME STORAGE – ZONING REQUIREMENTS

The Department of Environmental Health and Quality, Food and Housing Division (DEHQ-FHD) is responsible for evaluating and approving the use of a private home to store a permitted Compact Mobile Food Operation (CMFO). The CMFO owner is responsible for complying with any other local requirements in the city where the CMFO will be stored. Any specific storage requirements for the different jurisdictions in San Diego County are listed below along with contact information for each jurisdiction should operators have any additional questions.
