SUBJECT: FINANCIAL ASSISTANCE FOR CLOSURE OF SINGLE-WALLED UNDERGROUND STORAGE TANK SYSTEMS

To: Underground Storage Tank Owner or Operator

Single-walled underground storage tanks (USTs), including single-walled piping, must be permanently closed in accordance with Health and Safety Code, chapter 6.7, section 25292.05 by December 31, 2025. The State Water Resources Control Board (State Water Board) with the United States Environmental Protection Agency (U.S. EPA) have begun the *Single-Walled Underground Storage Tank Closure Initiative* (Initiative) to assist owners/operators in meeting their single-walled closure obligations.

Through the Initiative, U.S. EPA contractor, Redhorse Corporation (Redhorse) is reaching out to single-walled UST owners/operators that may be eligible for grants or loans through the Replacing, Removing, or Upgrading Underground Storage Tanks (RUST) Program. Redhorse will assist UST owners/operators with identifying financial resources available and completing RUST grant and loan applications for closing single-walled systems. For those owners/operators who desire, Redhorse will also assist with RUST grant and loan applications for newly installed double-walled systems.

RUST grants and loans are available to UST owners/operators in financing up to 100 percent of the costs necessary to remove, or replace UST systems. Grants up to \$70,000 are available to eligible UST owners/operators. An additional \$140,000 in RUST grants may be available for remote public fueling stations for removing and replacing single-walled USTs. Remote public fueling facilities are public fueling stations with no other fueling stations within a 15-mile radius. Please refer to the enclosed funding program fact sheets and applications for additional information.

Three educational workshops have been scheduled with their times and locations listed below. These workshops will include State Water Board staff presentations by the UST Leak Prevention program on design, construction, and closure requirements; RUST program on loan/grant funding opportunities available to assist eligible small business owners/operators; and cleanup fund on funding available to assist eligible owners/operators with cleaning up petroleum-related contamination. Registration to attend the workshops is not required.
