Please be advised that the County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency received and has accepted for filing an application package for a modified Solid Waste Facility Permit for the Las Pulgas Landfill. The LEA is certified by the California Department of Resources Recycling and Recovery to enforce state laws and regulations at solid waste facilities within the County of San Diego, excluding the city of San Diego.

Description of Proposed Permit: The operator has submitted an application package to modify its Solid Waste Facility Permit (SWFP). The proposed SWFP modification will provide non-material updates to the SWFP, including: updates to remaining capacity, estimated closure date, references to supporting documents, LEA findings; and the Joint Technical Document. The permit modification will not result in an increase to operating hours or permitted daily tonnage.

LEA Findings: The LEA has reviewed and considered the information, including the environmental effects of modifying the Solid Waste Facility Permit for the Las Pulgas Landfill. An Environmental Assessment (July 2002) was filed by Camp Pendleton with the State Clearinghouse. Camp Pendleton issued a Decision Memorandum on July 09, 2015 that the proposed changes qualify as a Categorical Exclusion. No substantial changes are proposed in the project and the LEA finds that there are no significant environmental effects arising out of the issuance of this modified Solid Waste Facility Permit. A Notice of Exemption will be filed with the San Diego County Clerk and the State Clearinghouse
