In accordance with Title 27, California Code of Regulations (27CCR) §21660.3, please be advised that the County of San Diego Department of Environmental Health, Solid Waste Local Enforcement Agency (LEA) has received and accepted a Registration Permit application from Inland Pacific Resource Recovery LLC for a Chipping and Grinding Facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste facilities within the County of San Diego, excluding the City of San Diego.

This project is an existing Chipping and Grinding Facility. The application package reflects change to the landowner, and updates to the Compostable Materials/Chipping and Grinding Operation Plan and Odor Impact Minimization Plan, which require the operator to submit a new Solid Waste Facility Registration Permit application package for LEA review and processing. The facility location, operational area, tonnages, hours of operation, and traffic will remain the same.

LEA Determination: The facility is defined and authorized by California Code of Regulations, Title 14, Division 7, Chapter 3.1, Article 2. Because a Registration Permit cannot be modified or revised, a new

Registration Permit is required. The issuance of the new permit is a ministerial action by the LEA. A Notice of Exemption will be filed with the San Diego County Clerk and the State Clearinghouse.

A copy of the permit application is available for review by appointment at the Department of Environmental Health office located at 5500 Overland Drive, Suite 110, San Diego, California.
