The County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency has accepted an application package for a modification to the Solid Waste Facility Permit for the closed San Marcos Landfill. The LEA is certified by the California Department of Resources Recycling and Recovery, to enforce state laws and regulations at solid waste facilities within the County of San Diego excluding the City of San Diego.

Description of Proposed Permit Modification: The proposed modified Solid Waste Facility Permit includes a correction in the assessor parcel number, amendment to the Final Post Closure Maintenance Plan (FPCMP) and Non-Water Corrective Action Plan (CAP), and updates to the financial cost estimates for the FPCMP and CAP. The landfill footprint and perimeter boundary will not be impacted.

LEA Findings: The LEA has reviewed and considered the information, including the environmental effects of modifying this Solid Waste Facility Permit. No substantial changes are

proposed in the project and there are no substantial changes in the circumstances under which the project will be undertaken and finds that there are no significant environmental effects arising out of the issuance of this Solid Waste Facility Permit. A Notice of Exemption will be filed with San Diego County Clerk and the State Clearinghouse.
