NOTICE OF SUBSTITUTE PUBLIC INFORMATION MEETING

EDCO Station Revised Solid Waste Facility Permit

PUBLIC NOTICE IS HEREBY GIVEN in compliance with Title 27 of the California Code of Regulations (27CCR), Section 21660.4 that the County of San Diego Department of Environmental Health and Quality, Solid Waste Local Enforcement Agency (LEA) received an application package for a Solid Waste Facility Permit Revision for EDCO Station (SWIS# 37-AA-0922) on April 20, 2022. The application package was accepted as complete and correct per 27CCR Section 21570 on May 18, 2022.

Project Description: EDCO Station is an existing permitted solid waste transfer station/material recovery facility on 4.1 acres in a Commercial/Industrial area in the City of La Mesa. The proposed project would allow an increase in maximum daily tonnage from 1,000 tons per day to 2,000 tons per day; installation of an outbound scale and scale house; updates to the permit findings and conditions; and updates to the Transfer Processing Report.

Public Meeting: The LEA is required to conduct a public information meeting pursuant to 27CCR Section 21660.2 to provide information to the public and receive comments on the LEA's proposed action to revise the solid waste facility permit (SWFP). The LEA is allowed to substitute a previously held public meeting on the same project if the applicant does not object and if the meeting took place within one year prior to the date of the complete and correct determination by the LEA. Consistent with Government Code Section 54953, as amended by Assembly Bill 361, in relation to the COVID-19 State of Emergency and recommended social distancing measures, a virtual public meeting was held online via Zoom by the City of La Mesa Planning Commission on March 2, 2022 at 7:00 p.m. to receive comments and approve an amendment to the EDCO Station Conditional Use Permit (Project 2021-19) and to adopt a Negative Declaration SCH#2022010065. The LEA was recognized by the presider of the public hearing and was available to answer questions regarding solid waste facilities permitting specifications from the public, other entities and officials in attendance at the meeting. The applicant does not object to the LEA using a substitute meeting. This public meeting meets the requirements of 27CCR Section 21660.4 for substitute meetings. The decision to issue or not to issue the revised SWFP must be made by the LEA within 120 days of the date the application was deemed complete and correct and after

concurrence from CalRecycle. The LEA's preliminary determination is that the facility is required to revise the Solid Waste Facility Permit.
