1.	In accordance with San Diego Regulatory Code, Section 68.402, it is my intention to use the well again for supplying water by the date indicated above.		
2.	I understand that the well must be in a condition capable of supplying water.		
3.	I understand the well must be maintained in compliance with all County Code and CA Well Standards requirements.		
4.	I understand the well shall have no defects which may allow the impairment of quality of water in the well or in the water-bearing formations penetrated.		
5.	I will maintain the well covered such that the cover is watertight and cannot be removed except with the aid of equipment or the use of tools.		
6.	I will maintain the well so that it can be clearly seen. I understand I may need to install barriers to protect the well from damage.		
7.	I will maintain the area surrounding the well clear of brush and debris.		
8.	If I decide to destroy the well, I will ensure the well is destroyed under a DEHQ approved permit.		
9.	I understand that this approval is valid for one year from the date of approval, and that I must either place the well back in service, obtain a permit to destroy the well, or resubmit a declaration of intent to use the well again for supplying water.		
10.	I understand that I may be required to demonstrate compliance with any applicable code requirements upon request.		
11.	I understand that if I fail to meet these requirements or fail to maintain the well in compliance with all code requirements, I will be required to destroy the well under a DEHQ approved permit.		

I hereby certify that I have read and understand the above noted requirements for approval of the well to remain out of service for one year and agree to meet these requirements.
