**B. Park Fee Range Update:** The County will present a proposed modification of the park fee's structure, including the establishment of new fees.

**B. PLDO Funds** - The Department of Parks and Recreation (DPR) has requested input on its updated five-year park project priority list for the expenditure of Park Lands Dedication Ordinance (PLDO) funds. The LCPG is seeking community input on this matter.
