 - A. Tree removal at 8910 Troy Street. Continued from meeting of 8/13/13. Removal of three palm trees. SDGE will pay for removal and for eight fruit trees for the Spring Valley Youth and Family Coalition. Presenter: Cunningham. Proponent: Steve Nelson: DPW. Cunningham presented photos of the project, and had a discussion with members of the Group. Cunningham made a motion to remove the trees. Vote 9-2-1. Daly and Lowes against. Eble abstained.
 - B. Park Lands Dedication Ordinance Project Priority List 2013-2014. Parks and Recreation Program Priority List, 2013-2014. Annual update of priority list of eligible projects. Presenter: Wilkinson. A discussion was held, and the priority list was decided upon. Wilkinson made a motion to present the list to the County. Vote 12-0-0. Motion carried.
