Administrative Items

Sheri asked Michael De La Rosa about some signage along Procter Valley Road. Answer: go to the Safety Center and speak to Code Enforcement.

Item #4: Michael De La Rosa community update: Now that fall is here, we are gearing up. The Willow Street Bridge project is starting.

Most of the issues are about saving vegetation. The equine ordinance is going to be adopted at 10 horses per acre.

Item #4: Review plans of Total Deliverance Church-5790 Quarry Rd. 3300-12-003 Cross Street Sweetwater Road. Jim Spruill presenting. This item had been tabled last month. After reviewing the photos that were presented, and learning that the requests that we made were followed e.g.: foliage against the building on the Quarry Road side; any tall lighting be downward directed, and the steeple removed.
