PDS2013-MUP-13-013 Deer Springs AT&T Mobility, Major Use Permit 684 Deer Springs Road:** AT&T Mobility is proposing to install 12 panel antennas and 24 Remote Radio Units (RRU's) and 4 'squids' mounted on a new, 35-foot high mono-broadleaf tree. The equipment necessary to support the site will consist of outdoor equipment located inside a new, 12' x 30' x 8' high CMU enclosure with metal gate for noise attenuation and compliance with Policy FP2. Two (2) GPS antennas will be installed on a steel trellis-type cover on the enclosure. The 8' high CMU enclosure will be a noise control element. AT&T will plant eight (8) additional trees to provide screening of the site from neighboring properties.
