PUBLIC COMMUNICATION

APPROVAL OF MINUTES

ADMINISTRATION OFFICE BUILDING REPLACEMENT (Jamie Abbott)

Mr. Jamie Abbott discussed potential ideas with the FAAC on the replacement for the Administration Office, or Operations Building, at Fallbrook Airpark. Mr. Abbott stated in a presentation that a replacement for the Administration Office, or Operations Building, at Fallbrook Airpark was anticipated in the next 2 to 3 years.

AIRPORT DIRECTOR'S REPORT (Jamie Abbott)

Mr. Jamie Abbott provided information pertaining to the Runway Rehabilitation Project at Fallbrook Airpark.

REAL PROPERTY'S REPORT (Carmela Gutierrez)

Excusing the absence of Carmela Gutierrez, Jamie Abbott discussed hangar compliance and lease matters at Fallbrook Airpark, including the current hangar use on leased premises and the pending lease renewal of the Fallbrook Tennis Club.

AIRPORT MANAGER'S REPORT (Meadow Chase)

Under security items, Ms. Meadow Chase stated that piggy-backing behind vehicles through airport access points or gates was strictly prohibited at Fallbrook Airpark, referencing the County of San Diego Airports Rules and Regulations.

Under maintenance items, Ms. Chase stated a temporary asphalt patch was installed on Wednesday, July 30, 2025, on a taxilane near the self-serve fuel station at Fallbrook Airpark.

Ms. Chase presented a historical graph depicting the monthly operations counts at Fallbrook Airpark for 2025 and four years prior. She reported the operations counts as 3,350 in May, 2025 and 3,232 in June, 2025.

NEW BUSINESS

Mr. Jerry Aberle, representative of Fallbrook Air Service at Fallbrook Airpark, posed questions to the FAAC and to the County of San Diego relating to future on-site management services of the County of San Diego at Fallbrook Airpark.
