APPROVAL OF MINUTES

The minutes from the Thursday, December 11, 2025, special meeting were noted and approved without changes. Motion was made by Mr. Tom Wilson and Mr. Phil Delaney to approve without changes, passing with the ayes of all present.

INSTALLATION OF NEW CHAIR & VICE CHAIR

Motion was made by Mr. Ken Kalbfell and Mr. Phil Delaney to nominate Mr. Tom Wilson for Chair and Mr. Thomas Bowman for Vice Chair, passing with the ayes of all present.

AIRPORT DIRECTOR'S REPORT (Jamie Abbott)

Mr. Jamie Abbott provided information pertaining to the Runway Rehabilitation Project at Fallbrook Airpark, stating that it was currently on schedule to be completed by the anticipated end date of Friday, February 20, 2026. Mr. Abbott also stated that there were no updates available on the Operations Building replacement at Fallbrook Airpark. Mr. Tom Wilson

expressed intentions to provide at an undetermined date and time a visual depiction or exhibit along with other related information to the County of San Diego Airports on what was desired by the FAAC in the Operations Building replacement at Fallbrook Airpark.

REAL PROPERTY’S REPORT (Carmela Gutierrez)

Ms. Carmela Gutierrez provided information pertaining to the non-aviation leases of Altman Specialty Plants and Fallbrook Tennis Club. Ms. Gutierrez also provided information pertaining to the lease compliance of L18 Airpark, LLC, at Fallbrook Airpark.

AIRPORT MANAGER’S REPORT (Meadow Chase)

Under security items, Ms. Meadow Chase stated that Inter-Con had replaced Allied-Universal in providing the contract security services at Fallbrook Airpark. The FAAC expressed a collective desire that contract security officers at Fallbrook Airpark resume both exterior and interior patrols on airport property. Under maintenance items, Ms. Chase reported no items.

Ms. Chase presented a historical graph depicting the monthly operations counts at Fallbrook Airpark for 2025 and four years prior. Ms. Chase reported the monthly operations counts for Fallbrook Airpark as 3,306 in October, 2025, 3,410 in November, 2025, and 3,734 in December, 2026, with the total operations count for the year 2025 being 37,758.
