If Applicant's request is granted, in Applicant's access shall be subject to the following terms and conditions:

Applicant shall abide by applicable provisions of the California Motor Vehicle Code, the San Diego County Code of Regulatory Ordinances, the Airport Rules and Regulations and the Airport Policies and Procedures and the provisions of the Lease/License between the County and the undersigned Master Leasehold under which Applicant is operating.

Applicant has and shall maintain for the duration of the access period a current and valid driver's license for the type of vehicle to be operated and vehicle liability insurance. Applicant shall carry proof of driver's license and insurance at all times while driving on Airport property.

- Applicant's right to access is limited to the locations and purposes stated above and subject to suspension and/or revocation in accordance with California Motor Vehicle Code, the San Diego County Code of Regulatory Ordinances, the Airport Rules and Regulations and the Airport Policies and Procedures and undersigned County lease
- 2. Applicant shall notify Airport Administration, in writing and within fifteen (15) days, of any change to the information provided in this application.
- 3. Applicant shall not be granted vehicle access until Applicant has demonstrated to County's satisfaction that Applicant has successfully completed the Gillespie Field Driver Training.
- 4. In accordance with Section 85.407 of the San Diego County Code of Regulatory Ordinances, the County of San Diego, and its agents, officers and employees, assume no liability or responsibility, and shall not be liable or

- responsible other than as required by law, for any loss, damage, destruction, injury or death to any person or persons or to any property by reason of any accident, incident, occurrence or mishap of any nature whatsoever or from any cause whatsoever. Any person entering an airport, or using or seeking or preparing to use an airport or any airport facility, does so at such person's own risk.
- 5. County shall not be liable for, and Applicant shall defend and indemnify County and its elected officials, officers, agents, employees and volunteers (collectively "County Parties"), against any and all claims, deductibles, self-insured retentions, demands, liability, judgments, awards, fines, mechanics' liens or other liens, labor disputes, losses, damages, expenses, charges or costs of any kind or character, except excluding attorneys' fees and court costs (hereinafter collectively referred to as "Claims"), which arise out of or are in any way connected to the operations covered by use of Airport by Applicant arising either directly or indirectly from any act, error, omission or negligence of Applicant or its officers, employees, agents, contractors, licensees, invitees, patrons, or guests, including, without limitation, Claims caused by the sole passive negligence or the concurrent negligent act, error or omission, whether active or passive, of County Parties. Applicant shall have no obligation, however, to defend or indemnify County Parties from a Claim if it is determined by a court of competent jurisdiction that such Claim was caused by the sole active negligence or willful misconduct of County Parties.
