Dear Roger,

We are in receipt of the notice and agenda of a special meeting of the PAAC on Thursday, December 6, 2018, at 7 p.m. and the proposed amendment regarding PAAC membership and selection. We do appreciate the changes that reflect that additional cities may put forth a candidate to represent their respective city. In keeping with the selection of representatives of cities, we would appreciate selection requirements expanded to all members of PAAC.

For selection of PAAC members we suggest the following:

- The Palomar Airport Advisory Committee Chair position should not have any financial interest in the airport! As the Committee Chair provides leadership to the PAAC, we propose that the Chair must be as neutral and unbiased as possible. *This follows your revision to members who represent cities cannot be a member of a governing body, planning commission or employee of city or county.*
- All members of the PAAC, including the Committee Chair, should have no longer than an 8 year term. This should be a retroactive

requirement and follows the current San Diego County Board of Supervisors term limits.

- ALL candidates must divulge:
  1. Comprehensive Bios addressing business experience, community associations, group memberships and current employment must be posted on the McClellan-Palomar Website.
  2. Interest in the airport, financial or otherwise, including **but not limited to:**
    - Leasing-property, aircraft, pilots, insurance associated with property, aircraft, etc.
    - Aircraft Sales
    - Rental Cars
    - Maintenance
    - Services
    - Fuel Sales or Provider
    - Etc.

Any candidate forwarded for consideration as a PAAC representative must be considered. If the Supervisor for the Fifth District finds any city nominee unsuitable, the Supervisor shall state in writing the reasons for such disqualification and provide the city an opportunity to nominate an alternate nominee. This process should be explicitly followed until a suitable candidate is agreed upon. This position should never revert to an appointment without the City submitting the candidate for approval.
