

Lease Amendment to Extend Term 5 years

County Airport agrees that if approved this amendment is an equitable opportunity to help restore revenue lost from the lingering effects of COVID-19.

To take advantage of this option:

- Lessees must be in compliance with their lease language.
- The lease term will not pass a cumulative 50- year term.
- At time of this lease extension, the current monthly rent will not be increased, unless the lease is scheduled for a rent adjustment or any action that increases the monthly rent.
- Current monthly rent will continue during the 5-year extension period.
- Leases subject to all terms of the lease language during the 5-year extension.



Public Outreach

January 18, 2023, the Palomar Airport Advisory Committee was presented with this motion; the committee is requested to vote on this item tonight.



Recommendations

1. Find per CEQA that the lease amendment is categorically exempt from CEQA review

- 2. Approve and authorize the Director of Airports to execute, upon receipt, amendments for lease extension of term of up to 5 years and take any other actions necessary to administer the lease.
- 3. Waive the application of Board Policy B-29, full cost recovery, to the proposed lease extensions, which are proposed to address the negative impacts of the COVID (4 VOTES).
