GENERAL INFORMATION

- This form complies with Order WQ 2022-0057-DWQ, NPDES Number CAS000002, "National Pollutant Discharge Elimination System General Permit for Stormwater Discharges Associated with Construction and Land Disturbance Activities."
- Projects with a Stormwater Pollution Prevention Plan (SWPPP) or Water Pollution Control Program (WPCP) require the information on this form to document amendment acceptance and certification.
- Water Pollution Control Manager signature block must be signed and certified by a Qualified SWPPP Developer (QSD) for SWPPP Amendments.
- Water Pollution Control Manager signature block may be signed and certified by a Qualified SWPPP Developer (QSD) or Qualified SWPPP
 Practitioner (QSP) for WPCP Amendments.

FORM

- 1. Provide a description and justification of the amendment.
- 2. If the amendment qualifies as a Change of Information for SWPPP / LUP projects, then attach a completed Form CE-2044.
- 3. List and attach all supporting documentation as applicable.
- 4. Record the amendment on the amendment log.
- 5. Route the amendment package for all signatures.
- 6. Send to Resident Engineer for acceptance and approval.
- 7. When the Resident Engineer has approved the SWPPP / WPCP amendment, the Resident Engineer will complete the form with their name, the approval date, and their certification.
- 8. The Resident Engineer will route the completed amendment package to the Contractor for filing in the onsite SWPPP or WPCP.
- 9. The Resident Engineer will file the completed amendment package in the office SWPPP or WPCP.
- 10. The Resident Engineer will provide the amendment package to the Stormwater Permit Coordinator for SMARTS upload, as applicable.
