Project Description: The proposed action includes constructing a new asphalt-concrete berm and drainage inlets along Sweetwater Road and a post and rope fence along the pathway to separate pedestrians from the road. The project will benefit the community by preventing storm-related erosion to the pathway which will enhance pedestrian safety, accessibility, and walkability.

Statement of reasons why project is exempt: Section 15301 of the California Environmental Quality Act (CEQA) Guidelines exempts from CEQA review, actions consisting of the "operation, repair, maintenance, permitting, leasing, licensing or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of existing or former use." The key consideration is whether the activity involves negligible or no expansion of an existing use. The proposed action consists of the construction of an asphalt-concrete berm and drainage inlets along the public road to prevent storm-related erosion of the existing pathway. In addition, the project will construct a post and rope fence along the pathway to separate the pedestrian pathway from the road. This project will benefit the community by preventing recurring storm-related erosion of the pathway during rain events and thus enhance pedestrian safety, accessibility, and walkability. As such, the proposed action will result in the minor alteration of existing public roadways involving negligible or no expansion of existing or former use. Accordingly, the proposed action is categorically exempt from CEQA pursuant to Section 15301 of the state CEQA Guidelines.
