

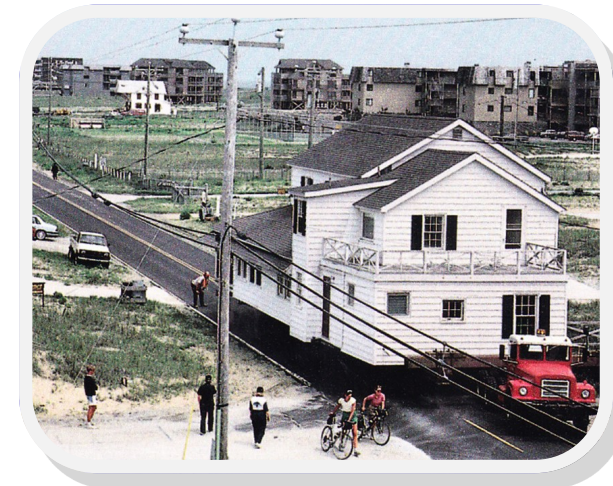


## GENERAL REQUIREMENTS

- ◆ Loads that can be reduced or redistributed are not eligible for Moving Permits.
- ◆ Applicant is responsible for checking the route prior to the move.
- ◆ The permitted route must be followed except in emergencies.
- ◆ All extensions must be properly flagged and any detached objects must be secured.
- ◆ No convoys of structures shall be permitted.
- ◆ Required tree trimming or removal of obstructions within the right-of-way shall be completed prior to move.
- ◆ The mover is responsible for all requirements and conditions of the permit.

## MOVING PERMIT

### PERMIT REQUIRE FOR A SINGLE TRIP

Legal loads on County Maintained Roads are defined in Division 15 of the California Vehicle Code (CVC) in terms of maximum height, width, length and weight for various types of vehicles. All extra-legal loads moving in the County of San Diego require an approved Moving Permit

**Type 1 Moving Permits:** Applications must be submitted at least 2 working days prior to the intended move for extra-legal loads that do not exceed each of the following criteria:

- ◆ Width: 14' Overall
- ◆ Height: 17' Overall
- ◆ Length 90' Overall (5 axles or less)  
110' Overall (6 to 9 axles)
- ◆ Weight: CVC Legal Loads
- ◆ Drives: Single drive vehicles
- ◆ Route: Not on Restricted Road List
- ◆ Hours: 9 :00 am to 4:00 pm

\*\$16.00 permit fee

**Type 2 Moving Permits:** Applications must be submitted at least 5 working days prior to the intended move for extra-legal loads that do not meet each of the Type 1 criteria. These moves require route evaluations prior to issuance of the permit.

\*\*\$218.00 Permit review and route evaluation fee is required for loads over 15' wide and 15' high..

### PERMIT REQUIRE FOR A BLANKET ANNUAL PERMIT

**Blanket Annual Moving Permit** may be obtained by customers who move extra legal loads on a regular basis.

Equipment/Structures: Legal dimensions for a blanket annual moving permit shall not exceed the following:

- ◆ Width: 14' Overall (Equipment)  
12' Overall (Structures)
- ◆ Height: 15' Overall
- ◆ Length 90' Overall (5 axles or less)  
110' Overall (6 or 9 axles)
- ◆ Weight: CVC Legal Loads
- ◆ Drives: Single drive vehicles
- ◆ Route: Not on Restricted Road List
- ◆ Hours: Sunrise to Sunset, all days  
\*10' wide unladen valid 24 hrs

\*\*\*\$90.00 permit fee

- ◆ A complete Moving Permit Application
- ◆ A valid California Vehicle Inspection Report for each vehicle
- ◆ For building or mobile home moves, a valid Building Permit for placing a building on a site in the County.
- ◆ Permit fee (check payable to "County of San Diego" for:
  - \* \$16.00 permit fee for Type 1 Moving Permit applications, or
  - \*\* \$257.00 permit and route evaluation fee for Type 2 Moving Permit application or,
  - \*\*\* \$90.00 permit fee for Blanket Annual Moving Permit application.

### Other Restricted Roads

SEC. 72.243.2. VEHICLES RESTRICTED FROM A PORTION OF VIA DE SANTA FE.

Only cars and pickup trucks may lawfully travel on the section of Via De Santa Fe between Calzada Del Bosque and Via De La Valle

SEC. 72.243.10. SAN MARCOS.

Tandem Axle tractors in combination with tandem axle trailers and single rear axle tractors or pickups pulling a tandem axle trailer with a distance greater than 23 feet between the rear axle of the pulling vehicle and the front axle of the tandem trailer shall not be permitted to travel on the section of Buena Creek Road between South Santa Fe Avenue and the End of County Maintained Limit.

SEC. 72.243.11. VEHICLES RESTRICTED FROM A PORTION OF SOUTH GRADE ROAD.

Tandem axle tractors in combination with tandem axle trailers and single rear tractors or pickups pulling a tandem axle trailer with a distance greater than 23 feet between the rear axle of the pulling vehicle and the front axle of the tandem trailer shall not be permitted to travel on the
