

SMALL CELL WIRELESS FACILITIES PERMIT

PERMIT REQUIRE

A Small Cell Wireless Facilities permit is required before installing a Small Cell Wireless Facility (SCW) within the unincorporated County.

APPLICATION PROCEDURE

Step 1: Submit application and checklist to applicable PDS Counter.

- For SCWs to be installed within a County Maintained Road, submit to Land Development Counter
- For SCWs to be installed on private property, submit to Zoning Information Counter

Step 2: Staff will review application for completeness.

The application must include:

- Small Cell Wireless Facility Questionnaire
- Contractor's License and Proof of Liability Insurance
- Financially Responsible Party Agreement
- Traffic Control Plan and Application
- Structural Evaluation (if applicable)
- RF Emissions Report
- Proof of Public Notice
- Site Agreement/Letter of Authorization
- Scope of Work

Step 3: Pay applicable fees to the cashier before submittal is deemed complete

Steps 4+: The applicable department will review your application and provide comments to the Applicant.
