 - City of San Diego
 - The Zero Waste Plan update and implementation plan is expected to be heard by the Committee in January 2020.
 - Details of the upcoming City-sponsored Green Routines Workshop at the Otay Mesa-Nestor Branch Library (12/7) were announced.
 - The City will host its [Annual Christmas Tree Recycling Program](#) through December 26, 2019 – January 23, 2020 where residents can drop-off their Christmas trees for recycling at one of 17 locations available throughout the City.
 - City announced that Carmen Romo has taken a new position at the City of San Diego in the Planning Division.
 - County of San Diego
 - The County is in process of hiring two Recycling Specialist II positions.
 - Proposed changes to the County's Construction and Demolition recycling Ordinance is scheduled to be heard by the Board of Supervisors in January 2020.
 - Posts for the regionwide messaging campaign to promote recycling correctly and reduce contamination began on 11/8/2019. Thank you to all those participating.
