4. Staff Reports

- City of San Diego
 - San Diego City Council passed the expanded polystyrene ban (1/8).
 - City is in the process of completing annual checks of their food waste program participants.
 - The City highlighted the success of UCSD's zero waste event, which achieved a 99% diversion rate. The event will be included in the organics program quarterly update.
 - The City will also be moving forward with construction and demolition recycling program outreach. The City will hold 3 events and 2 trainings throughout the year for builders and developers.

County

- The County announced the upcoming Used Oil Filter Exchange Event at participating AutoZone stores (3/23).
- The County is planning for a tire amnesty event in April.
- The County continues implementing the Strategic Plan to Reduce Waste and is proceeding with stakeholder outreach for proposed changes to the construction and demolition ordinance. The County is also working with Planning and Development Services to propose zoning revisions related to organic materials management.
- County is interested in expanding manure diversion.

 EDCO is moving forward with improvements to the Construction and Demolition facility in Lemon Grove to increase the capture rate.
