3. REVIEW OF THE FEBRUARY 7, 2019 MEETING SUMMARY

Stephen Mergener, Zero Waste San Diego: Stephen announced the upcoming 30th Annual San Diego EarthFair at Balboa Park (4/28). 5. CHAIRPERSON'S REPORT

Eric Wolff, County of San Diego: The County is holding a stakeholder outreach meeting to discuss proposed changes to the construction and demolition recycling ordinance (3/20). Eric also announced the upcoming Used Oil Filter Exchange Event at five participating AutoZone stores (3/23). 6. PRESENTATION

Tina Matthias and Katharine Mathews, Living Coast Discovery Center: The Living Coast Discovery Center (LCDC) offers zero waste solutions for both onsite and offsite events. LCDC's Zero Waste Event Program includes working with the event partners and vendors to follow sustainable practices in order to minimize waste and reach a 90% diversion rate or higher. Prior to the event, the LCDC provides event partners with a zero waste policy and educational materials with recommended types of compostable and recyclable serve ware to offer during the event. Sorting stations monitored by trash talkers are available during the event to educate attendees on how to properly sort their waste into the appropriate compost, recycle, and liquid waste collection bins. After the event, the waste collection totals are calculated and organic materials are composted onsite. Since the program was implemented in January 2018, the Zero Waste Event Program has composted 11,000 pounds of organic waste, and collected 6,000 pounds of recyclables. 7. SUBCOMMITTEES' REPORT

- **a. Household Hazardous Waste-** The group is following SB 212 rulemaking. This bill will establish a stewardship program for the collection of medications and sharps.
 - i. IWMTAC members discussed the FDA pharmaceutical drug flush list.
- **b. Organics-** The group reported on the following:
 - i. SB 1383 comment period closed March 4.
 - 1. TAC members expressed interest in sharing/reviewing comment letters that were submitted.
 - ii. The group is reviewing the draft San Diego County Compost and Mulch Market Assessment.
 - 1. TAC members are interested in reviewing the document.
 - iii. Member interest on the status of the City of San Diego's districted franchise collection.

8. LEGISLATION

Eric Wolff, County of San Diego: Eric reported on the following:

- AB 755-would increase the California tire fee by \$1.50 and deposit it into the Stormwater Permit Compliance Fund.
- AB 815-would require CalRecycle to find that a jurisdiction made a good faith
 effort to implement its source reduction and recycling element if the jurisdiction
 adopted a dual stream recycling program.
- AB 1080- would establish the California Circular Economy and Plastic Pollution Reduction Act which would require CalRecycle to adopt regulations to source reduce or recycle 75% of single-use packaging and products by 2030 and require all single-use packaging and products sold or distributed in California be either recyclable or compostable on and after 2030.
- AB 1488-would expand California Beverage Container Recycling Program reporting requirements to include beverage container reclaimers.
- AB 1583-would delete the prescribed triangle used on the label for all rigid plastic bottles and containers.
- AB 1770-would extend the operation of the Rubberized Pavement Market Development Act to June 30, 2024.
- SB 667-would develop financial incentive mechanisms to fund organic waste recycling infrastructure.
- SB 724-would increase the number of convenience zone exemptions for beverage container recycling centers and return processing payments to their 2015 levels.

9. ROUNDTABLE

IWMTAC Members: Members proposed holding future TAC meetings/tours at recycling related facilities. Potential sites include CR&R's facility in Perris and Living Coast Discovery Center.
