  - County of San Diego
    - The County will launch the Recycle Right campaign on August 17. This is an informational campaign that focuses on recycling correctly and reducing contamination.   - Association of Compost Producers
    - Interest in regional bioresources management in preparation of upcoming SB 1383 requirements.
    - Discussion on polyfluoroalkyl substances (PFAs) on paper products.
  - Carton Council
    - Carton Council is working on the upcoming CRRA conference. There will be schools track on 8/18.

    - Sierra Club held the first zero waste subcommittee meeting. Member interests include plastics and policy. Interest in expanding to food waste and composting.

7. Legislative Update

- [AB 2287](#): *Solid waste*. Current law prohibits a person from selling a plastic product in the state that is labeled with the term “compostable,” “home compostable,” or “marine degradable” unless the plastic products meets certain specifications. Current law also prohibits the sale of a plastic product that is labeled as “biodegradable,” “degradable,” or “decomposable,” and prohibits implying that a plastic product will break down, fragment, or biodegrade or decompose in a landfill, unless the product meets one of several standards. This bill would authorize the Director of CalRecycle to issue guidelines for determining whether a plastic product is not compliant with these labeling requirements and whether a plastic products is designed, pigmented or advertised in a manner that is misleading to consumers among other things.
- [AB 2959](#): *Solid waste: byproducts from the processing of food or beverages*. Current law authorizes each jurisdiction to determine whether solid waste handling services are provided for by means of a nonexclusive, partially exclusive or wholly exclusive franchise, contract, license of permit and prohibits entities from exercising that authority with regard to the hauling of byproducts from the processing of food or beverages if certain conditions are met. This bill would reauthorize those local governmental entities to exercise that authority if those byproducts originate from a supermarket, grocer, restaurant, or other retail food establishment.
- [AB 3163](#): *Energy biomethane: procurement*. Current law requires the Public Utilities Commission, in consultation with the State Air Resources Board, to consider adopting specific biomethane procurement targets or goals for each gas corporation so that each gas corporation procures a proportionate share of biomethane annually. This bill would define “biomethane” as methane produced from an organic waste feedstock, rather than biogas, that meets specified standards.
- [SB 409](#): *Illegal dumping*. Current law makes it unlawful to dump waste matter in certain locations and makes it unlawful to place, deposit, or dump rocks, concrete asphalt, or dirt in certain locations. This bill would make it a crime to transport waste matter, rocks, concrete, asphalt, or dirt for purposes of dumping it in certain locations.
- [SB 1156](#): *Lithium-ion batteries: illegal disposal: fire prevention*. Would prohibit a person from knowingly disposing of a lithium-ion battery in a container that is intended for the collection of solid waste or recyclable materials.
