2. SB 1383

- a. Capacity Planning Mandates for Food Recovery
 - i. SDFSA Update on regional survey
 - 1. Currently incorporating feedback on the survey and will send out the updated version soon (1-2 weeks).
 - 2. Working on a 1-page handout as a primer for the survey.
 - 3. Potentially hosting a collaborative webinar with the food banks
- b. Tier 1 & 2 Questions & Discussion about grey area criteria
 - i. Food service providers education at the primary location, what is a primary location?
 - Primary location = Headquarters/main office (= where records are kept).
 May differ per FSP based on their company organization (centralized v decentralized).
 - a. If HQ is out of the state we do not contact them.
 - 2. How to determine if a grocery store counts, based on a "certain %" of grocery items being sold?
 - a. Supermarkets that are not on the convenience list, do they still count as grocery stores based on sales/square footage?
 - b. Stores like Target, Walmart with multiple uses use primary use, sales, square footage, # of personnel? Let's try to be consistent

- throughout our region, although some customization may need to occur.
- c. Use google maps/google street view to estimate square footage and determine if 1 or 2 stories.
- 3. Strip malls and plazas
 - a. Defined as a large venue like a mall food court?
 - b. Some share waste/recycling, some are individual.

3. Understanding the Food Recovery Landscape

- a. Presentations:
 - i. Jacobs & Cushman San Diego Food Bank Kayla Thompson
 - 1. Centralized food hub in San Diego. Acts as a connecting agent between donors and food pantries.
 - 2. Recover and distribute food throughout the entire county.
 - 3. Physical infrastructure: 2 warehouses (Miramar and Vista), Processing (sorting, bagging, compost and recycling center), distribution.
 - 4. Resources: Programs (federal, Super Pantry, Diaper Bank), Nonprofit Services (compliance, assistance), Food Bank University (classes, grant writing, donor retention).
 - 5. Food Recovery: General donations (pick ups of larger volumes), Food pick up (by nonprofit partners)
 - a. Food Rescue Program: Fresh rescue, meal rescue, backyard rescue (gleaning)
 - 6. Donor onboarding includes training on food safety methods.

- b. Feeding San Diego Kerri Kolarik
 - 1. Not a traditional food bank they keep food local to the area it was rescued. Do not store in a centralized warehouse, although they do have a small warehouse that can be used.
 - a. 225 farms/packing sheds, 320 distribution partners
 - 2. Meal Connect = Feeding America donation app (website and smartphone)
 - a. Food recovery partner agencies are trained in food safety and carry thermapens, freezer blankets, and scales.
 - b. Meant for smaller quantities (1-2 pallets).
 - 3. Donor onboarding for recurring doantions includes an onboarding meeting (usually onsite), phone call with one-time donors about food safety and a written acknowledgement.
 - 4. Currently, some corporate stores hold contracts with Feed America (much closer to an informal agreement).

- c. Dream Center San Diego (Summit Church in San Marcos) Peter Whittet
 - i. Donate, Don't Dump program
 - 1. 2012 Farmers Market style, select what you'd like
 - 2. 2016 partnership with Feeding San Diego. No refrigeration, so all food came in a left as soon as possible.
 - ii. Night on the Block at CSU San Marcos. Now participate in Tuesday night farmers market.
 - iii. They are a Meal Connect partner, part of the Super Pantry program.
 - iv. No reports of illness due to donations.
 - v. Contact info: peter@aare.org
 - vi. Received 2 San Diego Food Bank cold storage grants bought a 20 ft cold box, 3 door commercial freezer, 2 door commercial freezer, 2x20 ft dry storage units.
 - vii. Emergency Food and Shelter program 20 ft dry storage unit (now have 3 total)
 - viii. Open Sunday, Tuesday, Thursday, 2nd and 4th Saturday.
 - ix. Receive food through San Diego Food Bank and Feeding San Diego regular pick-ups and deliveries, in additional to Meal Connect.
 - x. Connect other partners/churches with the Food Banks to get their programs started.
- d. I Love to Glean Karen Clay
 - i. Warehouse in Chula Vista.

I Love to Glean South County Food Hub Recovery Service

Gets lead for Generator Recovery and carries the financial and resource burden by providing the transportation, correct cold storage needs, large warehouse space and coordination of volunteers from agencies to sort and pack the food for distribution. Agencies then take back to their locations for distribution.

ii. Submitted a proposal to the City of Chula Vista for a 2-year pilot program to establish a consolidated food recovery program.
