| a. <a href="#">Regional edible food organization webinar</a> – Thursday Oct 7, 2-3pm.  | Discussion |
| i. Intended to educate food recovery organizations (FROs) about the upcoming survey and how SB 1383 may affect them.   |            |

1. County will distribute survey, hoping jurisdictions can assist with follow up.
  2. County will collect the information from the survey, and provide each city their information for analysis. Analysis due back to the County to be passed on to CalRecycle.
  - c. Capacity planning checklists for jurisdictions – County review + questions
  - d. Capacity planning questions from 9/2 presentation – discussion
  - e. DEHQ Inspector Training
    - i. Sept 23 – to understand SB 1383 requirements.
    - ii. DEHQ expecting to field questions regarding SB 1383.
  - f. Tier 1 & 2 – Questions & Discussion about grey area criteria
    - i. Discussion about identifying specific generator types. Please see [Google Doc](#) for updates.
    - ii. Strip malls are not malls (per CalRecycle verbal guidance)
    - iii. Discussion regarding inclusion of “grey area” Tier 1 and 2 facilities. Including them now could inflate the amount of potentially edible food, potentially increasing the gap in edible food recovery capacity.
    - iv. Suggestion not to include these facilities until more CalRecycle guidance is released and a definitive decision is made.
    - v. To get square footage info: Use of Google Maps measure tool (Google Maps Pro shows area without having to do math) and real estate listings. Can also look up “address + square footage” and Loopnet will tell you square footage (beware of combined strip mall/shared spaces).
    - vi. Most jurisdictions are not currently performing site visits, relying on phone/email to determine Tier 1 or 2 status.
- 5. SB 1383 – Public Education Resources** INFO + Discussion
- a. Food generator training video –
    - i. Steve Weihe (County of San Diego) is working with County videographer to create this video intended for the whole County. Aiming for Oct/Nov release. DEHQ is also involved to encourage food donation and discuss liability.
  - b. CalRecycle Pub Ed Campaign – update from CalRecycle (if any)
    - i. CalRecycle will reach out to City of San Diego and County of San Diego for feedback and vetting of materials. Will then rollout to all jurisdictions once complete.
  - c. *Save The Food, San Diego!* Campaign – update from SDFSA
    - i. Building a website as a centralized resource with a focus on residential and businesses. Aiming for early-2022 release.

- a. CalRecycle asking to peer share SB 1383 and edible food recovery resources.
  - i. City of Carlsbad currently creating outreach they are happy to share once complete (anticipated before Jan 2022). Handouts include SB 1383 overview and how to sign up with a food recovery organization.
- b. CalRecycle note that ultimately the edible food recovery agreement is the responsibility of the FRO, questioning if SDFSA or the food banks will share templates for smaller organizations.
  - i. SDFSA working with Oceanside to create something to this effect.
  - ii. Food banks also have templates they can share, but note that each agreement will have to be customized to the FRO and generator.
