- Welcome and Introductions – Rick Anthony, Ellyn Law, Fernando Moreno, Derek Lam, Bob Sly, Beryl Flom, Hemant Phadnis, Stephen Mergener, Bob Hill
- Approval, Minutes May 2022 – Approved no changes.
- Chair's Report
 - The Chair participated in a panel at Waste Expo discussing the Cool Now Program which aims to divert compostable organics from the landfill.
 - Richard Anthony Associates is working with the County and Cities of Carlsbad and Chula Vista on tier 1 edible food generator outreach.
 - The Chair is also working on a work plan to close the incinerator in Montgomery County, Maryland.
 - The 2022 [CRRA Conference](#) will be held in Oceanside September 6-9. This year's event will be a hybrid conference, available live as well as online.
- Staff Reports
 - City of San Diego
 - City provided an update on palm fronds and the resources recovery park following questions from a previous meeting.
 - The City is wrapping up their contract with I Love a Clean San Diego. The next contract year will include expanded education and outreach at community workshops, booths, school presentations and additional multi-family complex outreach. Upcoming events include outreach booths at Kobey's Swap Meet.
 - The City is continuing community planning presentations regarding SB 1383 and will presenting to town councils next.
 - Upcoming events with Solana Center include Vermicomposting Basics Webinar (6/29), Smart Ways to Fight Food Waste Webinar (7/12), All About Worms Workshop (8/13), and Backyard Composting Basics Webinar (9/22).
 - County of San Diego
 - The County is outreaching to Tier I and II sites for food donation education and assistance.
 - The County will be conducting site visits to construction and demolition sites in the coming months.
 - Staff continue to conduct outreach and site visits to commercial and multi-family complex units.
 - EDCO
 - EDCO is conducting SB 1383 outreach to multi-family complexes and commercial businesses.

- EDCO has upcoming events in La Mesa and Vista offering shredding services, e-waste collection and free mulch giveaway.
 - EDCO is conducting an allocation and waste characterization study on their collection streams.
 - Upgrades to the EDCO Lemon Grove facility have been completed.
- League of Women Voters San Diego
 - The League is continuing the effort to repeal the People's Ordinance and provided a presentation to the Rules Committee.
 - Chair discussed adding support of this effort to a CAC committee vote at the July meeting.
