- 2. **Public Comments & Communications** (Guests who wish to speak on a matter that does not appear on the agenda may do so during this period)
 - a. ProduceGood SB 1383 grant for local jurisdictions. Note that they work throughout the county and are willing and able to increase capacity for edible food recovery.

3. SB 1383 – Rollout roundtable

- a. Regional edible food org survey County to provide update
 - a. Survey sent out countywide on Friday, Nov 5th.
 - i. Technically closed on 1/7, but survey is still active and FROs can still participate.
 - b. County received 103 surveys as of 1/10/22
 - c. SDFSA is working on aggregating data for jurisdictions and will provide data by jurisdiction directly to individual jurisd.
 - d. County to share FRO's lists by jurisdictions + survey language (shared document)
 - e. Food banks were only replying on the survey for direct donations recovered by them (not including their partner organizations). So no double counting.

- a. Next key date: 2/1 County will request send formal request to jurisdictions for edible food recovery capacity info listed above
- b. 6/1: Jurisdiction deadline to submit capacity info due to County (120 days to respond)
- c. Tier 1 & 2 Questions & Discussion about grey area criteria
 - a. Solana Center community colleges/UCs/state schools are non-local entities (and therefore <u>not</u> Tier 1 or 2 on their own), but include food service providers, restaurants, and/or large venues (which do qualify as Tier 1 or 2). Notes will be placed in the SharePoint document.
 - b. County SB 1383 Working Group currently identifying County facilities that may qualify as Tier 1 or Tier 2 for food recovery.
 If there are any County facilities in your jurisdiction, please feel free to reach out to the County.
- d. DEHQ -Organics Collection guidance
 - a. EDCO's "The Right Way" video https://www.cityoflamesa.us/386/Waste-Recycling
 - b. Waste Free SD Bin Cleaning Services now available
 - i. Carts only at this time.
 - ii. 4 services available now. Please contact the County if you hear of additional services.
 - c. DEHQ Guidance document to be released mid-January.
 - d. Solana Center contacted County of Santa Clara about organics collection, since they have been collecting organics for ~10 years:
 - i. Vectors are not deterred by plastic bags. No numbers to show that unbagged organics collection increases vectors.
 - ii. In many cases, organics were collected more frequently than recycling and trash (for businesses).
 - iii. Feedback from local restaurants they prefer totes to dumpsters as they seal better.
 - e. City of Oceanside note that their businesses prefer the dumpsters and use the lock bars.
 - f. Note that businesses do not believe they can bring organics totes inside overnight (per DEHQ). This is not true ordinance language to be provided.
 - g. City of SD has required that dumpsters get retrofitted with rubber to hold organics. They get warped over time and haulers must replace upon customer request.
 - h. City of La Mesa previous experience from San Francisco. If rats are cited as an issue, it is usually from the surrounding area (not occurring because of organics in bins). Raccoons were also an issue as they can physically open the bins, bungees or locks are recommended.

- e. Recordkeeping & Reporting (FRO's and Generators)
 - Concerns from FRO's on recordkeeping and reporting requirements
 - i. Note that the CalRecycle tool contains lots of legal jargon, and smaller FRO's do not have legal teams.
 - ii. Model agreement has 2 options (donor recordkeeping or FRO recordkeeping on their behalf).
 - iii. Model recordkeeping contains a breakdown of Tier 1 and 2 donors (tracking these separately takes significant time)
 - b. Pending clarity from CalRecycle meeting scheduled this week between CalRecycle, County of SD, and SDFSA.
 - c. City of SD per SB 1383, food recovery organizations do not need to be 501c3. Just cannot be for-profit.
 - d. Solana Center discussion regarding donation dumping. Can agreements be used as a tool to discourage donation dumping?
 - I Love to Glean inspects all donations before accepting.
 Sets the bar high from the very beginning. Has refused donations in the past due to temperature or visual inspection.
 - ii. Feeding San Diego suggests communication with donor ask why this happened (new staff, mistake, operational errors, etc). Also encourage taking pictures of unacceptable donations to show to managers and other staff.
 - iii. SDFSA note that this can be a difficult bar for FRO's to set retroactively with existing donors. They would like to maintain the relationship for the edible food they do receive and have historically accepted a certain amount of dumping. Do not want to hinder the relationship, would appreciate jurisdictions' support in communicating with donors.

- e. Who to list in public outreach materials to donors? Two main food banks or smaller agencies as well? Has anyone done this? Survey shows?
 - a. City of Chula Vista compiles a full list of donors (not just food banks). Once list is vetted the full list will be a resource for donors.
 - SDFSA recommends getting permission from each organization to see if they want to be listed as a public resource. Note that ~25% of FRO survey respondents said they

- would like to be contacted directly, other 75% said through a food bank.
- c. SDFSA and County will share which orgs are interested in being listed, and which ones are not, once data is aggregated in Jan.
- d. City of SD <u>mailer to Tier 1 generators</u> with full <u>food recovery</u> org list
