#### 3. SB 1383 - Rollout roundtable

- a. Capacity Planning Presentation Stephanie Ewalt
  - Jurisdiction responsibilities estimating amount of edible food that will be disposed by Tier 1 and 2 generators, identify existing capacity at food recovery organizations, identify proposed or new food recovery services.
  - 2. County responsibilities County to aggregate data and submit to the state, including jurisdictions that lack capacity. County required to report to CalRecycle by Aug 1.
  - 3. 2/11/22: County sent formal request via email to jurisdictions for edible food recovery capacity (and organics planning)
  - 4. 6/11/22: Jurisdiction deadline to submit capacity info due to County.

- 5. 32% response rate from confirmed fresh rescue partners, 13% response rate from unconfirmed partners.
- 6. Food recovery org survey available through March 31.
- 7. Q: City of Solana Beach how to account for food capacity that is available regionally, if a jurisdiction does not have any (or a lot) of FRO's in their jurisdiction?

A: the survey asks FRO's to identify how much they rescue from each jurisdiction (ex: 25% Solana Beach, 50% City of SD, etc.)

8. Q: City of SD - how does survey address those that partner with the food banks, to avoid double counting?

A: food banks did not include any fresh rescue in the survey, only the food that they actually recovered.

- d. Tier 1 & 2 Questions & Discussion about grey area criteria
  - 1. Do marathons count? Yes the food banks confirmed that they have each recovered from marathons before (oatmeal packets, fresh whole fruit, bars, etc)
  - 2. Would like to discuss how to record large events, including street vendors where donation isn't appropriate.
  - 3. City of Oceanside suggests getting good info from the event upfront to see if food donation is appropriate.
  - 4. ProduceGood would like clarification on farmers markets. Ekolojik clarified that unless they are hosted by an agency, they are not Tier 2.
  - 5. DEHQ note that any prepared foods kept at 41-45 degrees must be destroyed at the end of the day (and cannot be donated).
  - Q: Oceanside will DEHQ provide food donation resources specifically for large venues or events?
     A: all events and venues are inspected by DEHQ as part of permitting, no specific brochure exists at this time.
  - 7. Q: City of SD question on seating v square footage. Does anyone know what the limit for fire code is?

A: No solid answer. May still depend on kitchen/dining room ratio, some restaurants now have additional outdoor seating, etc.

- f. Recordkeeping & Reporting (FRO's and Generators)
  - 1. Concerns from FRO's on recordkeeping requirements
  - 2. CalRecycle guidance ok for FRO's and jurisdictions to report a combined total of food recovered. Do not need to separate out only Tier 1 and 2 generators
  - 3. Sharing Tier 1 and 2 generators lists with food banks. Will help food banks continue to identify generators not donating, and will help to set them up to donate.
    - i. I Love to Glean suggestion to distribute this info to the smaller FRO agencies or to make it publicly available. Don't only give the info to the large food banks (don't make the list exclusive).
    - ii. County note that just because a generator is donating doesn't mean they are donating the maximum, and that jurisdictions must conduct inspections on all Tier 1 and 2's (regardless of if they are already donating or not).
    - iii. SDFSA note that this came about because FRO's were curious if any of their existing donors were Tier 1 or 2 (and therefore needed contracts).
    - iv. Oceanside note that Tier 1 and 2 generators may not want to be listed publicly and contacted by FRO's. May need to ask for their permission to post that info. Also consider exactly what info would be shared on this list.
    - v. County are contracts customary? Onus for the contract is on the generator right? yes, onus is on generator.
      - 1. Feeding SD has some contracts with large national donors (ex. Target, Walmart), but not on the local level. Working on amending those now for SB 1383 compliance.
      - 2. Oceanside simplified the CalRecycle model food recovery agreement to make it more manageable and agreeable for smaller FRO's (more of a form that the donor and FRO complete together). Stephanie (Jimbo's) noted that it has been helpful that the food banks provided an agreement for her business, and that the CalRecycle one was onerous.

## 5. SB 1383 - Organics Collection Concerns from Food Recovery Orgs

Brief discussion points from SDFSA/group discussion

- a. Oceanside note that collection costs will increase 10-50% for most generators, but they may offset costs by right-sizing. Dumping can also present an issue with contamination fees. Oceanside accepts clear plastic liners for commercial food scraps to mitigate odors/vectors (not for residential). If your hauler doesn't take plastic liners, empty the contents into the organics bin and toss the liner in the trash. Note that bin cleanings/swap outs are often available for a small fee.
- b. SDFSA note that a pay for food donation model would make it more sustainable for FRO's.
