  - i. I Love to Glean Is there going to be any tie back with the other jurisdictions regarding Vision 2030?
    - SDFSA Want to create policy coalitions for food recovery capacity with this data, more info to come...

    - i. County of San Diego As you are doing your disposal and capacity numbers, please include population inflator in the survey results.

  - b. EDD Data from County
    - County of San Diego A one-time snapshot of 2021 data, County will not be keeping or accumulating data on an ongoing basis.
  - c. June 11 is a Saturday, so June 13<sup>th</sup> is ok.
    - i. For submitting capacity data to the County.
  - d. Checklists are updated in resource list below.
- c. Tier 1 & 2 Questions & Discussion about grey area criteria
  - a. County of San Diego Updating regional spreadsheet as questions have been clarified by CalRecycle.
  - ProduceGood Since many jurisdictions have received CalRecycle funding, are you going to be covering what cities are doing assessment wise? References SDFSA's work with Carlsbad.
    - SDFSA Research work to understand existing food recovery programs and potential improvements for Carlsbad is separate and unrelated to CalRecycle funding.
    - ii. County of San Diego County has been awarded funds but has not received it yet, individualized by cities for how funds are being used.
  - c. City of San Diego Clarification on designation of education facilities, are all schools to be designated as Tier 2 generators?
    - CalRecycle Global education agencies are not just school sites but school districts as well, each school is not a Tier 2 facility unless they have an onsite food generation facility.
    - ii. Ekolojik According to CalRecycle, we are counting school districts as one Tier 2 generator, schools coincide with wherever their district office is located.

- iii. City of San Diego What about the County Office of Education?
  - County of San Diego County Office of Education would not apply, no onsite food generation facility
- d. Ekolojik Regarding wholesalers that prepare supplements, vitamins, protein powders, etc. CalRecycle said they are still edible, so they remain on the list (case by case basis)
  - i. City of San Diego CalRecycle should review those definitions and be a bit more reasonable to get at what we are trying to accomplish.
  - ii. DEHQ Does not regulate supplement wholesalers.
  - Ekolojik According to wholesaler, anything nearing expiration is discounted and anything past expiration is reprocessed into pet food.
  - iv. SDFSA Many food pantries do not accept supplements and are not prepared to provide advice on how to take supplements, treated the same as medication.
  - I Love to Glean Get the food bank's viewpoint on supplements, find out what they are advising their agencies to do.
    - Feeding SD They can make exceptions at times depending on supplement and demand. Distributor centers are not barred from accepting supplements, same with protein powder. There are policies for baby formula and over-the-counter medication.
    - 2. San Diego Food Bank Does not accept supplements, aside from food items (including meal replacement drinks and bars). Over-the-counter medication is not accepted.
- e. Ekolojik If we find edible food in the compost bin, is it a violation? Where do we draw the line?
  - i. County If someone has something arrange for animal feed that is fit for human consumption, is that a violation? Is there a hierarchy of regulation or does anyone's ordinance address this?
  - ii. Jimbo's Want to divert more organics to animal consumption when not donate-able, currently only customer to coworker scale. Are there regulations or support to create a partnership between retailer & local farmer?

- CalRecycle Send questions to either Roberta Goldenpenny or SLCP inbox to be answered later.
- f. County of San Diego Site visit last week with wholesale distributor, mentioned that once avocados hit the ground, they are inedible. Is this abundance of caution from the wholesaler or elsewhere?
  - DHEQ Unsure what the wholesale distributor is referring to, the produce can be used. Donatable per food service code assumes the consumer would take produce home and wash it, most likely wholesalers' own clarification.
  - ii. City of San Diego Site visit with food packaging facility, told that having an organic compost facility is not okay, regulations from FDA and USDA.
    - DEHQ Does not regulate a lot of generators, only deals with retail foods. May be beneficial to reach out to FDA and USDA to get those discussion going and align them.
  - iii. County of San Diego SB1383 does not require generators to report, are jurisdictions writing that in their ordinances?
    - 1. Ekolojik Yes, it was an option in the model ordinance and jurisdictions modified the text how they wanted.
    - 2. County of San Diego County does not expect to get annual reports and site visits are not required annually. Some site may require more oversight than others.
    - 3. SDFSA Is there a centralized location for understanding the differences between record keeping and reporting across different jurisdictions?
      - a. County of San Diego Hope to have data synthesized soon.
        - i. Tier 1 & 2 Criteria for Grey Areas
- d. Other roadblocks, concerns for discussion
- e. Recordkeeping & Reporting (FRO's and Generators)
  - a. Concerns from FRO's on recordkeeping requirements
  - b. CalRecycle guidance ok for FRO's and jurisdictions to report a combined total of food recovered. Do not need to separate out only Tier 1 and 2 generators
  - c. Sharing Tier 1 and 2 generators lists with food banks.

Will help food banks continue to identify generators not donating and will help to set them up to donate.

- 1. SDFSA Open to food bank information being the source for reporting.
- 2. County of San Diego Generators do not have to report, just keep records. Whether the records are generated by the agency or food banks, if the info is there it is fine.
- Ekolojik Details for accepted and rejected foods are very jurisdiction specific and mostly on the generator to prepare those tallies.
- 4. County of San Diego If the partner agencies are keeping records, they can give them to the food generators. The generator is going to be responsible.
- 5. Solana Center Would like CalRecycle to weigh in on whether generators need a formal tally or if they can rely more on food banks data for the tally.
