#### 3. SB 1383 - Rollout roundtable

a. Regional edible food org survey

Discussion

- a. Access to Survey Questions for continuation of outreach
- b. Tableau Results available
- c. Food Recovery Capacity Survey Results (5/27/2022)

- d. County has been conducting outreach to FRO's
  - i. County of San Diego County staff and contractors reached out to remaining 25% of confirmed fresh rescue orgs (~50 orgs). Final capacity numbers pending.
  - ii. City of Oceanside Were you only surveying fresh rescue orgs? Does that only include dry goods?
    - County of San Diego and Food Banks No, fresh rescue is a categorization from the food banks, also includes rescuing shelf-stable and frozen foods.
- b. Implementation Plans (for jurisdictions lacking capacity)
  - a. SB 1383 language
  - b. Timeline (120 days from County submission to the state)
    - i. Mid-November if submitted at the end of July
  - c. Plan to include timelines, milestones, funding, etc.
  - d. Implementation plan if regional surplus?
    - CalRecycle For individual jurisdictions with a deficit but regional surplus, those jurisdiction must submit a formal implementation plan.
    - ii. City of Oceanside Asking for clarity on capacity planning responsibility between jurisdictions and counties.
      - CalRecycle Intended as regional collaborative effort between counties in coordination with cities/other jurisdictions before Aug 1
    - iii. County of San Diego Will start sending emails to jurisdictions this week regarding sharing their status on capacity deficit/surplus for regional coordination.
    - iv. CalRecycle Implementation schedule is not intended to be a state enforcement process.
      - CalRecycle If there is a regional deficit, all
        jurisdictions will need to submit implementation
        plan. CalRecycle to verify this with the County.
      - 2. From CalRecycle's website: "If a county identifies a need for new or expanded edible food recovery capacity, then each of its jurisdictions must submit an implementation schedule to CalRecycle with a plan to ensure enough new or expanded capacity to recover the edible food currently disposed of by its mandated food donors."
      - 3. CalRecycle Will pass along information from counties that have taken a regional approach with the group (Santa Clara County and Yolo County).
    - v. County of San Diego We are not submitting a report as the County, but instead checking off boxes on whether a jurisdiction responded and if they are lacking capacity.

- vi. Solana Center Is there concern with sharing excess capacity amongst the other jurisdictions?
  - 1. County of San Diego will be emailing jurisdictions for approval to share their food recovery capacity.
- vii. County of San Diego How much tolerance is there for waiting and verifying the actual capacity since these numbers are all theoretical and cannot be confirmed without site visits?
  - 1. CalRecycle Nothing beyond what is within the regulations.
- viii. County of San Diego Does an implementation plan need funding?
  - 1. CalRecycle Funding is not required; however, funding is a result for the need to increase capacity, crux of the implementation plan.
- ix. Solana Center If there is a regional deficit, does CalRecycle want one regional plan that all jurisdictions contribute to or will each jurisdiction with a deficit need to provide a plan?
  - 1. CalRecycle All 19 jurisdiction must submit a plan if there is a deficit, but CalRecycle will confirm with the County.
- c. Tier 1 & 2 Questions & Discussion about grey area criteria
  - a. SB 1383 v USDA requirements?
    - County of San Diego During a site visit, an avocado food distributor stated that any food that touched the ground was considered inedible/not donatable per USDA requirements.
      - 1. CalRecycle Currently being vetted by legal on how to respond.
  - b. Food donation v animal feed?
    - i. CalRecycle If the food was edible for human consumption it needs to be recovered for human consumption and not animal feed.
    - ii. General discussion regarding animal feed.
      - CalRecycle Generators may send food scraps for animal feed; however, depending on the amount going to landfill, organics collection service may be required.
      - Ekolojik Section 18983.1 Landfill Disposal and Recovery: (b) Organic waste sent to one of the following facilities, operations, or used for one of the following activities, and not subsequently sent

for landfill disposal, shall be deemed to constitute a reduction of landfill disposal.

- c. Sharing Tier 1 and 2 generators lists with food banks to confirm which generators have existing agreements; or
- d. Can food banks provide lists of donors by jurisdiction?

    - i. Counties first reporting in February 2023.
