**1. QUORUM**

**2. WELCOME AND INTRODUCTIONS**

**3. REVIEW OF THE JANUARY 5, 2023 MEETING SUMMARY – Reviewed. No comments.**

**4. PUBLIC COMMENTS AND COMMUNICATIONS**

**Mallika Sen, Solana Center:** The Solana Center received the US Composting Council award for organics diversion program of the year! University of California Irvine was awarded a grant from the U.S. Department of Energy to improve California's economy and environment through better recycling practices. Solana Center will work with UC Irvine on the project to develop a model on recyclable material flows and associated greenhouse gas emissions. Solana Center continues to hold public outreach events and workshops. Event details are available on Solana Center's [website](#).

**Stephen Mergener, Zero Waste San Diego:** The 10<sup>th</sup> annual Zero Waste Symposium will be held on February 21 at the County Operations Center. This year's symposium will focus on a global overview and local actions. [Registration](#) is open through February 17. A list of upcoming Fixit Clinics was shared including San Diego (2/11), Carlsbad (2/25), Lemon Grove (3/11), and Carlsbad (4/1).

**Michael Luna, City of Del Mar:** Michael will be the TAC representative for the City of Del Mar moving forward.

## 6. PRESENTATION

**Maria West and Christina Files, CalRecycle:** CalRecycle provided an overview of the I Recycle Smart Campaign Toolkit. The Campaign is designed to educate Californians about the importance of waste reduction, recycling, and composting, promote positive behavior change, and measurably improve Californian's recycling, composting, waste reduction and sustainability actions. The [toolkit](#) includes a series of resources available for jurisdictions to use including videos, audio ads, social media ads, print ads, and digital display ads. CalRecycle hosted a series of webinars on the campaign and recordings are available on their [website](#).

## 7. CALRECYCLE UPDATE

**Cara Morgan, CalRecycle:** Cara reported on the following:

- CalRecycle is hosting a SB 1383 chat with a focus on edible food recovery on 2/15.
- Thank you to the jurisdictions for submitting the Electronic Annual Report. The Compliance and Enforcement branch has sent out letters acknowledging receipt of the report. Review is anticipated to be complete at the end of February. Jurisdictions were informed via listserv of changes to RDRS disposal data. If you have questions, please reach out to your LAMD contact.
- 127 jurisdictions submitted SB 619 notifications. Once plans have been approved, they will be posted on CalRecycle's website.
- The video [recording](#) on How Biomass Electricity Can Satisfy SB 1383 Requirements is available.

- CalRecycle staff held an informational session on SB 54. The meeting recording will be available shortly.
- CalRecycle will begin SB 1383 compliance evaluations. Notifications will be sent out prior to the evaluation. Every jurisdiction will be reviewed in the next four years. Feedback on the process is welcomed.
- An update on [grant/loan opportunities](#) was shared including Organics Grant Program (coming soon), Farm and Ranch Solid Waste Cleanup and Abatement Grant Program (due 2/9), Illegal Disposal Site Abatement Grant Program (due 2/15), Legacy Disposal Site Abatement Partial Grant Program (due 2/15).

**Doug Kobold, CPSC:** A legislative update on the following bills was shared:

- [AB 246](#), Menstrual products: perfluoroalkyl and polyfluoroalkyl substances (PFAS). Intent bill.
- [AB 347](#), Pollution Prevention and Hazardous Source Reduction and Management Review Act: enforcement.
- [AB 348](#), Beverage containers: producer responsibility score.
- [SB 244](#), Right to Repair Act.
- [SB 271](#), Powered wheelchairs: right to repair

**Michael Luna, City of Del Mar:** Michael asked the group who was responsible for non-local entities that are food generators. Response was jurisdictions are responsible for education and CalRecycle is responsible for enforcement.

**Mallika Sen, Solana Center:** Mallika noted that some corporate edible food generators have tighter restrictions than foodbanks.

**Michael Luna, City of Del Mar:** Michael asked the group if any jurisdictions have partnered with entities to run food distribution programs within the city.

**Avecita Jones, City of Carlsbad:** The City of Carlsbad has food recovery funding available and is seeking applications to help expand the volume of edible food recovered. Additional information is available on Carlsbad's [website](#).

**Colleen Foster, City of Oceanside:** There is a Southern California SWANA workshop on 2/23 in Ontario focusing on edible food recovery.

**Doug Kobold, CPSC:** The Used Oil Conference will be held the second week of February in Sacramento. The next Illegal Dumping Conference is scheduled for 4/19-4/21.

**Manuel Medrano, City of Chula Vista:** Manuel noted the CalRecycle Beverage Container Recycling Grant.
