5. PUBLIC COMMENTS AND COMMUNICATIONS

6. CHAIRPERSON'S REPORT

Caitlin Barboza, County of San Diego: The Integrated Waste Management Technical Advisory Committee (TAC) meetings were established by the Board of Supervisors in partnership with the San Diego Association of Governments for the purpose of preparing the Countywide Integrated Waste Management Plan (CIWMP). The CIWMP is reviewed by the County every 5 years. As such, the County proposes to convene the TAC meeting when the CIWMP is being updated per the group's formation purpose. IWMTAC members discussed this topic which will be addressed again at the June TAC meeting.

Vanessa Mello, County of San Diego & Kate Garrett, Feeding San Diego: The County of San Diego Department of Environmental Health & Quality (DEHQ) implements the California Retail Food Code. Vanessa provided an overview of DEHQ's role in SB 1383 as it relates to food donations under the retail food code and how to donate food safely. Kate presented an overview of edible food donation including identifying edible food donations, limitations to donating, and best practices.
