#### 3. Presentation

- a. Commercial Deconstruction The Reuse People Ted Reiff, Founder
  - i. The Reuse People look to reduce the solid waste stream by salvaging building materials and distributing them for reuse.
  - ii. The Reuse People act as a distribution hub for recovered materials in the Bay Area and partners with certified contractors to complete commercial deconstruction.
  - iii. They offer a free white paper on Designing and Implementing a Deconstruction Ordinance. It can be found here.
  - iv. City of Chula Vista Can you elaborate on the data you provide to clients after recovery?
    - 1. Economic Donatable Amounts
      - a. It typically offsets the costs of deconstruction at the residential level. Tax incentives are lower at the commercial end.
    - 2. They also can compute embodied energy and carbon.
  - v. Joanne Brasch- What opportunities have you seen for solar panels?
    - 1. Reuse People often takes solar panels and have seen people reuse it for alternative uses other than solar collection.
  - vi. ZWSD Are you all looking into a market in San Diego?
    - 1. They are looking to establish a small warehouse.
  - vii. County of SD Challenges with documenting reuse process?
    - 1. For their facility, everything that enters the facility is weighed by a public scale first. Inventory is then taken to show additional proof.

2. They are also going to set lumber minimums and compare it to the original amount of lumber built into the house so they can estimate recovery percentages.
