3. Open Forum

- Jessica Toth Solana Center.
 - i. Tie Dye workshop is coming up this Saturday at Solana Center. Rochester Institute of Technology has a sustainable materials flow course; Solana Center can help with discounts if interested.
 - ii. SB1383 Food Recovery Inspector Training begins on November 5[,] 2025, it is 3 half days. Community events offered in advance of SB707, Responsible Textile Recovery Act.
 - iii. A small group went to the County Board of Supervisors to present on the proposed waste fee increase.

4. Presentations

- I. PaintCare Recycling Made Easy Valentina Hopkins
 - Valentina presented on the paint stewardship laws on behalf of architectural paint manufacturers, governed by a Board of Directors representing architectural paint manufacturers. PaintCare was formed in 2009 in response to paint stewardship legislation based on a pilot in Oregon.
 - ii. There is approximately 884 million gallons available across the nation for recycling, which is enough paint for 8 1/2 million homes. An estimated 10% of architectural paint goes unused each year.
 - iii. Established in October 2012, there are 820 year-round drop-off sites and 42.5 million gallons collected thus far.
 - iv. Program goals are to increase convenience and recycling opportunities through retail drop-off sites to reduce the cost and add responsibility for state and local governments through those HHW partnerships to manage payment in an environmentally responsible manner and to establish sustainable funding.
 - v. And what does that pain care fee fund?
 - a) 70.3% goes towards paint collection, transportation and processing.
 - b) 21.4% goes towards staffing admin overhead and state oversight fees
 - c) 8.3% goes towards outreach and education.
 - vi. Businesses have some restrictions on oil-based products.

 They can only drop off 25 gallons per month and must sign drop off, log or receipt. They must be a Very Small Quantity Generator (VSQG)
 - vii. PaintCare is looking to participate in more is city mural projects, with examples in Palmdale and east coast, but none yet in San Diego.

 Looking for opportunities in the county utilizing reuse paint.
 - viii. 6. NSAC Update – Heidi Sanborn

We have a working group that is national and meets every other month on household hazardous waste.

- I. SB343 On the truth in labelling for what's recyclable, which is having national impact, the industry's already asking the federal government to prevent states from enforcing truth in labeling. Education and outreach for the ongoing program is required. Truth in labeling was passed in California years ago (2021).
- II. AB1325 (Rodriguez) Requires producers who are responsible for automotive products like engine oils and transmission fluids to form a Producer Responsibility Organization (PRO) which is funded by the oil and lubricant association. They recently joined NSAC on a study trip to Canada.
- III. SB54 Packaging Producer Responsibility Act We are expanding it to all EPR packaging, bringing in other people from different states. Kickoff call will be December 15, 2025
- 7. CPSC Update Joanne Brasch We are in between the ledger year. Currently, meeting with stakeholders, coming up with plans for January. Working on recalled products, specifically Anker brand battery packs which are showing up in transfer stations.
 - I. SB 707 Responsible Textile Recovery Act (2) Textile events in southern California; none in San Diego. There's a couple jurisdictions CPSC is interested in, some local ordinances or even local adoption of programs and collection opportunities that are complementary to SB707.
 - AB 80 Carpet Recycling It's going to be heard in appropriations and retailers are proposed to pay a fee.
 - II. AB 864 (Ward) Regulatory Streamlining for Solar Panel Recycling. Bill is paused on floor of the Senate. Two solar panel events in southern California; none in San Diego. Next January will re-introduce new bill with new author while Ward bill remains active.
- 8. Wasting Fee Update Rick Anthony I was just at three conferences, National Recycling Coalition, Zero Wast and the Global Forum in Turkey. The Zero Waste concept is being accepted.
- 9. SB 1383 Roundtable

No comments

- I. Manuel Medrano In interested in tours. Up to 20-30 people to any site that is related to agriculture or organics, such as a local urban farm. HHW is another submission on how to hard to manage waste and the solutions.
- II. There is a local conference committee formed. We understand there are local folks that want to be included too.
- III. Staying away from ocean and water themes and going for a regenerative approach, such as soil and agriculture.

11. Other Regional Working Group Reports

I. Ellyn Law – Edible Food Working Group

Had a meeting last week. There was no presentation. Attendees discussed site visits with food generators. At the County, we are preparing for the annual reporting and site visits to food recovery organizations. The County's Office of Emergency Services is soliciting feedback to improve its emergency contracts, with a discussion on how it relates to edible food recovery. Comments can be submitted by October 30th. The next meeting is November 18, 2025.

ii) Michael Wonsidler – Organics Working Group Discussed CRRA conference tours, including organics facilities. Recent workshop with San Pascual Soils was showcased. The County has been using a compost voucher program in providing compost to farms, which will go from internal support to a contractor Zero Foodprint. The next meeting is November 5th. Manuel Medrano added, City of Chula Vista is doing a composition study in 2026.

iii) Annabelle Jackson – Port of San Diego

Port is coordinating with CPSC, State Parks, the Coastal Commission and Clean Harbors, hosting another Marine Flare collection event.

Taking place on Saturday, November 15th from 8:00 am to 12:00 pm at our Shelter Island boat ramp parking lot. Kenneth Prue added, the City of Oceanside is also partnering in the event.
