- 2. County of San Diego Environmentally Preferrable Procurement (Natalia King):
 - a. Reimagining Board Policy B-67 EPP Report
 - i. EP3 Presentation: Natalia presented the proposed update for the Environmentally Preferable Procurement (EPP) policy, focusing on guidelines for purchasing decisions to increase equity and sustainability. She emphasized the importance of making greener choices without limiting competition or driving up costs.
 - ii. **Policy Guidelines:** Natalia explained the draft guidelines for the EPP policy, which include prioritizing previously owned products, avoiding chemicals of concern, and investing in energy-efficient products. She also highlighted the importance of evaluating vendors based on their environmental and social impact.
 - iii. Product Categories: Natalia detailed the specific guidelines for four product categories: furniture, office supplies, building and construction materials, and food serviceware. She emphasized the importance of prioritizing sustainable and low-impact products in these categories.
 - Furniture Guidelines: Natalia explained that the guidelines for furniture include prioritizing products made from sustainably certified or recycled materials, and avoiding those with high VOC emissions or harmful chemicals.
 - 2. **Office Supplies:** For office supplies, the guidelines emphasize reducing usage, prioritizing high-yield and remanufactured toner cartridges, and using paper with recycled content or sustainably sourced materials.
 - 3. **Building Materials:** The guidelines for building materials focus on using reclaimed wood, low or zero VOC paints, and avoiding products with harmful chemicals. These measures aim to reduce environmental and health impacts.

- 4. **Food Serviceware:** For food serviceware, the guidelines prioritize reusable items, and if not feasible, compostable options without harmful chemicals. This aims to reduce waste and chemical exposure.
- b. Next Steps: Natalia outlined the next steps for the EPP policy, including creating guidance documents and training for county staff. She also mentioned an upcoming circular economy assessment to identify opportunities for sharing, reusing, and upcycling products and materials.
