## COUNTY SERVICE AREA 26A - COTTONWOOD VILLAGE - PROPERTY OWNERS MEETING

This letter is being sent to you because you own property located within County Service Area 26A – Cottonwood Village. County Service Areas are special districts formed by residents through the public referendum process to fund expanded services, such as landscape maintenance. County Service Area 26A (CSA 26A) funds open space and landscape maintenance for 1,325 parcels in Rancho San Diego. The County of San Diego provides maintenance services on behalf of the property owners using revenue from special benefit assessments which are placed on the tax rolls.

The annual revenue generated by CSA 26A's assessment is ~\$127,000. The current revenue and fund balance are not sufficient to continue to support the CSA's current services which have averaged to be \$159,000 annually in recent years.

The current rate for CSA 26A is \$56.29 per benefit unit. Most parcels pay 1 benefit unit per year (\$56.29), however 313 parcels in the vicinity around Hilton Head Park pay one additional benefit unit for slope maintenance services (for a total of \$112.58 annually). The specific rate charged for your parcel is listed at the top of this letter and on your property tax bill.

Current services include the annual fire break clearance in open space areas, ornamental landscaping in medians and parkways on/near Brabham, and slope maintenance. For more information about CSA 26A, please visit:
