COUNTY OF SAN DIEGO EXPRESSION OF INTEREST FOR FORMATION OF A PERMANENT ROAD DIVISION ZONE

The purpose of the Expression of Interest form is to indicate preliminary support for the formation of a Permanent Road Division Zone (PRD Zone). A PRD Zone is a type of district that is used for the maintenance of private roads. Road maintenance services are paid by the property owners through assessments or special taxes collected through the tax rolls. Road maintenance services are provided by the County through contractors and are financed through assessments/special taxes, which are voted on by the landowners themselves. The boundaries of the PRD Zone include the properties that benefit from the road maintenance services and generally include properties fronting on or using the road(s).

We, the undersigned owners of property lying within the boundaries shown on the attached map, request the County of San Diego, to determine the feasibility of establishing a **PERMANENT ROAD DIVISION ZONE (PRD Zone)** in accordance with the provisions of the Streets and Highway Code (Sections 1160 to 1196) of the State of California for extended road services.

It is understood that the road must be declared a public road and the total cost of any improvements and continuing maintenance will be borne by the benefiting property owners. It is further understood that the costs will be shared by the owner of each parcel of land according to the benefits received and collected on the tax bill of all the properties within the PRD Zone.
