SAN DIEGO COUNTY EMS TRANSFER TO ED WAITING AREA OPTION

The San Diego County EMS Office actively monitors the health of the 9-1-1 delivery system. The ongoing surge in patients with respiratory infections has increased demands on the county's entire healthcare continuum. As part of a comprehensive strategy to preserve critical healthcare resources, including ambulance availability, the County of San Diego EMS Medical Director has issued a temporary adjustment to the EMS emergency department (ED) transfer of care procedure.

Effective **December 19, 2022, at 0700**, patients being transported by ambulance to the ED (within or outside the 9-1-1 system)¹ may be transferred to the ED waiting area under certain conditions.

To exercise the Transfer to ED Waiting Area Option, **EMS professionals must first communicate** with the ED triage nurse.

Prehospital and hospital personnel must confirm that all the following criteria are met:

- Anticipated Transfer of Care time is >30 minutes
- Age ≥18 years or accompanied by a parent/caregiver if <18 years of age
- Normal mental status (GCS 15 and oriented to person, place, time, and event)
- Normal vital signs for adults (or age-appropriate vital signs for pediatrics)
 - SBP ≥ 90 mmHq
 - o HR 60-100 bpm
 - o RR 12-20/min
 - SpO2 \geq 94% on room air
- Ambulatory with steady gait without assistance (as appropriate for age)
 - OR, for limited mobility patients, able to sit safely in wheelchair, if hospital staff available to provide ambulatory assistance
- Not suicidal
- Not on an involuntary hold, conservatorship, or when safety monitoring indicated
- No suspicion of acute substance ingestion or overdose
- No chest pain, syncope, dyspnea on exertion, or acute neurologic symptoms (e.g., focal weakness, dizziness, vertigo, imbalance)
- No ALS medications were administered in the field, including fluid boluses²
- No indication for ongoing monitoring or anticipation of repeat treatments administered in the field

¹ Enrollment in the LEMSIS ePCR platform is a requirement for EMT ambulance providers outside of the 9-1-1 system to use the Transfer to ED Waiting Area Option.

² If an IV TKO has been established, convert it to a saline lock prior to patient transfer to ED waiting area.

EMS professionals must adhere to hospital requirements for infection control. A patient shall only be transferred to the ED waiting area if COVID-19 and other infection control precautions, including source patient masking and physical distancing, can be maintained.

When exercising the Transfer to ED Waiting Area Option, EMS professionals shall deliver a full transfer of care report to the receiving ED staff and obtain a signature from the receiving facility's staff member.

EMS personnel shall document in the ePCR:

- fulfillment of all Transfer to ED Waiting Area Option criteria, and
- the patient's location in the ED waiting area (e.g., wheelchair, waiting area chair, triage tent, cot)
