# **B.** Administrative Report

- <u>2025 2026 EMS Treatment Protocols:</u> The San Diego County EMS 2025-2026 treatment protocol revision cycle concluded in April and all protocols and policies are posted on the County EMS website. The protocol and policy updates take effect July 1, 2025.
- <u>Kaiser San Marcos Medical Center:</u> We are pleased to share the exciting news that Kaiser San Marcos Medical Center has been officially designated as a County of San Diego EMS stroke receiving center. This designation is effective on July 1, 2025.

We welcome Kaiser San Marcos Medical Center as our nineteenth designated stroke receiving center, further strengthening our specialty care system.

- New Requirement for Automated Cardiac Compression Devices on July 1, 2025: As agencies
  were informed beginning in March of last year, protocol S-103 language was revised to state
  that automated cardiac compression devices will become mandatory for all ALS ground
  ambulances on July 1, 2025. This requirement was included in the educational materials
  distributed to all EMS agencies with the revised protocols on May 1, 2024.
- The LEMSIS System is always improving, and third-party data integration is in progress! The use of the LEMSIS system streamlines data management and ensures high-quality, patient-centered care. Additionally, agencies using the LEMSIS system fully comply with EMSA dataset requirements and OD Maps submittals, including AB40 (transfer of care) reporting requirements. The LEMSIS product, through the LEMSIS User Group, is always adapting to the dataset and user experience adjustments. The very active user group makes suggestions to improve the product monthly.
- <u>Public Comment Process:</u> Policy development is a continuous process. Staff are currently engaged in drafting multiple policies, which are anticipated to be released for public comment in the coming months. We encourage interested parties to regularly visit our website for updates on policies being posted for public review and feedback. A link to this site is also available on the EMS Mobile App.

Several additional agencies have linked their ePCR databases with the County's LEMSIS system over the past few weeks. We are now at approximately 92% of ALS transporting volume, still missing a few first responders beyond that number.

The LEMSIS User group met last week, focusing on improvements and optimizations to the LEMSIS ePCR form and workflows.
