IV. COUNTY REPORT - Brian Christison, Program Coordinator

Health Services Capacity Plan Level: Plan Level 5 – Baseline Surveillance (Level 1-5 – Five is Lowest)

Southern California Fire Preparedness Level: Plan Level 3 (Level 1-5 - Five is highest)

County EMS Fees and the next Fiscal Year:

In 2024, the Board of Supervisors supported a phased three-year increase for personnel, specialty care, and permitting fees. This phased increase requires annual validation that these fee stairsteps are accurate. The County's Emergency Services Administration Unit, together with the Auditor & Controller's Office, have finished the LEMSA fee review. The fee updates for the 2nd year are anticipated to be heard by the Board of Supervisors on April 22 and be effective July 1. EMS System Redesign Process Update:

The EMS Office has initiated two advisory committees to help guide the EMS System redesign process. Each of these committees have representatives from the Hospital Association, The Fire Chiefs Association and the Ambulance Association. These advisory committees will be discussing future pilot studies, equipment trials, and proposed policy adjustments. As a reminder, the final reports and periodic updates are posted on the San Diego County Engage Page..

Ambulance Ordinance Update:

The ambulance ordinance is undergoing an update to better align with current best practices and medical transportation standards. As part of this process, we want to hear from the community to help better understand their experience with the EMS delivery system and identify areas for potential improvement.

2025 - 2026 EMS Treatment Protocols:

We are finalizing the treatment protocol drafts to be presented at the EMS Medical Director's Advisory Committee (or BSPC) in the coming months. We look forward to showcasing the proposed revisions and receiving the community's feedback to better inform our decisions as we continue to pursue the most up-to-date and evidence-based treatments.

- New Requirement for Automated Cardiac Compression Devices on July 1, 2025: As agencies were informed beginning in March of last year, protocol S-103 language was revised to state that automated cardiac compression devices will become mandatory for all ALS ground ambulances on July 1, 2025. This requirement was included in the educational materials distributed to all EMS agencies with the revised protocols on May 1, 2024.
- The LEMSIS System is always improving, and third-party data integration is in progress! The use of the LEMSIS system streamlines data management and ensures high-quality, patientcentered care. Additionally, agencies using the LEMSIS system fully comply with EMSA dataset requirements and OD Maps submittals, including AB40 (transfer of care) reporting requirements. The LEMSIS product, through the LEMSIS User Group, is always adapting to the dataset and user experience adjustments. The very active user group makes suggestions to improve the product monthly.
