MINUTES

January 22, 2023

Chair Ijadi-Maghsoodi: Meeting was called to order at 12:05PM

Public Comments:

Business:

1) Commissioners each shared what motivated them to dedicate their expertise, skillset, and time to the CSWG.

2) Chair Ijadi-Maghsoodi presented an overview of Commissioners' roles and responsibilities based on County code and bylaws.

3) Brainstorming sessions:

(a) Brainstorm session 1: Commissioners shared issues they are passionate about and identified focus areas:

- Transgender and LGBTQ+ justice (including healthcare, housing, jobs)
- Caregiving, including childcare and parental leave, and elder care and addressing ageism
- Human sex trafficking
- Access to healthcare, including to reproductive services (including family planning and abortion) and sexual health services (including HIV services)
- DV, including support for homeless DV survivors, supporting survivors in leaving abusers, and the nexus between DV and teen dating violence against girls
- Wellness and body image
- Highlighting intersectionality across identities and issue areas
- Homelessness and housing, including addressing veteran and senior homelessness
- Immigration and refugees (especially because we are a border county)
- Addressing misinformation (e.g. on CEDAW) and hate speech
- Presenting community Know Your Rights workshops on key policy areas (e.g. housing, environment, healthcare, employment, immigration)
- Environmental justice and its connection to women and women of color
- Gun violence
- Financial freedom and women's job opportunities, including addressing genderbased discrimination in employment

(b) Brainstorm session 2: Commissioners shared 1 to 3 actions each Commissioner would like to see the Commission accomplish this year:

- Increase community engagement, including through education and communication initiatives and become a centralized hub for information on key women's issues
 - Participate in more tabling events to build community relationships and distribute CSWG materials, including brochures, business cards, and Commission promotional items
 - o Collaborate with Supervisors on an event
 - Highlight a women's or social service organization or collaborate with a nonprofit by helping raise funds or volunteering
 - Host forums on gender-based issues, including Know Your Rights workshops presenting information from trustworthy sources on key policy areas (environment, housing, immigration, employment, healthcare)
 - o Launch campaign to address misinformation (e.g. on CEDAW)
 - Create a newsletter that spotlights women's events, resources, and organizations, educates on gender-based initiatives and legislation, and shares relevant reports on the status of women
- Spotlight work of women's organizations, gender-based groups, and other service organizations (e.g. Rotary Club and its work on human trafficking) on social media
- Address transgender challenges through public statements in response to community events

- Highlight elder community needs, including uplifting organizations that work on housing unsheltered elders and addressing elder abuse
- Prepare support sheets (one-pagers) to post on our website and distribute to the community addressing elder support, education, healthcare, and homelessness for women
- Providing technical support to the San Diego City Commission on the Status of Women, specifically on its work supporting the adoption of CEDAW legislation
- Propose legislation for the County Board of Supervisors to increase duration of paid leave
- Advance or collaborate with the Supervisors in hosting a program to support low-income women, and women of color, with funds to become first-time homeowners
- Research and evaluate potential legislation for Board of Supervisors to adopt that would create a San Diego youth shelter devoted specifically to girls
- Research and valuate potential legislation for creation of a County childcare facility for county workers (on site if possible)

4) Discussion regarding the status of CSWG's committees, initiatives, and projects:

- CEDAW Committee Chair Ijadi-Maghsoodi
 - Commissioners on Committee: (5) Comms. Ijadi-Maghsoodi, Farjood, Vasquez, Cabrera, and Dr. Boyce
 - What is planned for this next year and already underway?
 - County ordinance implementation, which breaks down into three tasks (1) completing work on the RFP, (2) a Commissioner serving as a member of the Source Selection Committee, and (3) participation in the Gender Equity Working Group.
 - o Support to the city for a city ordinance.
 - Meetings: RFP subgroup meets as needed via Zoom or phone (Comms. Ijadi-Maghsoodi, Farjood, Vasquez). No full-Committee meeting date/time because Committee currently exceeds quorum, so must discuss only at CSWG meetings.

 - Commissioners on Committee: (1) Comm. Ludwig

 - Continue to inform and educate on key reports and local projects to address homelessness (e.g. through highlighting information from the Regional Task Force on Homelessness website).
 - Meetings: Currently none scheduled because one-Commissioner Committee, but this Committee will be subsumed into the Policy Committee.
- Human Trafficking Committee Chair, Commissioner Dr. Boyce
 - Commissioners on Committee: (1) Comm. Dr. Boyce (Comm. Cisneros-Remington previously on this Committee)
 - What is planned for this next year and already underway?
 - Collaboration with and support to community partners.
 - Meetings: Currently none scheduled because one-Commissioner Committee, but this Committee will be subsumed into the Policy Committee.

- Civic Engagement Chair, Vice Chair Cabrera
