Approval of Minutes:

February 3, 2023 – Commissioner Cabrera made a motion to approve the February 3, 2023 meeting minutes. Commissioner Ludwig seconded the motion. No vote due to Ludwig contesting her appearance at the February 3rd meeting. Staff

February 12, 2023 – Commissioner Goodwin made a motion to approve the February 12, 2023 special meeting minutes. Commissioner Ludwig seconded the motion. Motion passes with Commissioners Custodio Suero and Vásquez abstained and all other commissioners voting in favor of the motion.

March 3, 2023 – Commissioner Goodwin made a motion to approve the March 3, 2023 meeting minutes. Commissioner Ludwig seconded the motion. Motion passes with Commissioners Custodio Suero and Vásquez abstained and all other commissioners voting in favor of the motion.

Public Comments:

Former Commissioner Prisk asked if Bettina Hausmann would be sharing the importance and the power the CSWG could have at the UN Commission on the Status of Women (CSW). Chair Ijadi-Maghsoodi confirmed it would be addressed.

Business:

- 1. Presentation on San Diego Delegation to the UN Commission on the Status of Women
 - Bettina Hausmann, UNA-USA San Diego Chapter President/CEO, shared her life experiences growing up in East Germany and the impacts of WWII; how the US and UK came together to create the UN; how the United Nations Association (UNA) is membership based; and that the UNA-USA San Diego Chapter voted to give 5 seats out of 20 to the CSWG for the CSW.
- 2. New Commissioners Introductions
 - Commissioner Custodio Suero introduced herself and shared her background with the Commission.
- 3. CCSWG Grant Application
 - Commissioner Farjood shared information on the phase 2 grant application for the *Know Your Rights* training which is a 6-part series. Requested \$32,600 for the 6-part series workshop, onsite childcare, food, interpretation services if needed, and compensation for community partners who present or help with the workshop. Commission should be informed sometime between April 11th and 13th if they will receive funding for this initiative.
- 4. Support Letter for statewide CEDAW legislation
 - Commissioner Vásquez made a motion for the CSWG Executive Committee to create a letter of support for statewide CEDAW legislation. Commissioner Farjood seconded the motion. Motion passes with Commissioner Ludwig abstaining and all other commissioners voting in favor
- 5. Support for CSWG Proposing County Parental Leave Policy
 - Commissioner Vásquez made a motion for the CSWG Executive Committee to propose a County parental leave policy to the Board of Supervisors. Commissioner Custodio Suero seconded the motion. Motion passes with Commissioner Goodwin abstaining, Commissioner Ludwig voting nay and all other commissioners voting in favor.
- 6. Support letter for Santa Clara County CEDAW legislation
 - Santa Clara County will be voting on legislation on April 18th. Commissioner Goodwin made a motion for the CSWG Executive Committee to draft a letter of support for Santa Clara County CEDAW legislation. Commissioner Ludwig seconded the motion. Commissioner Farjood asked who is the

audience- BOS of Santa Clara? Chair Ijadi-Maghsoodi confirmed. Motion passes with all commissioners voting in favor of the motion.

7. Committee Reports
