January 3, 2025 **Hybrid Meeting 12:00 PM – 1:00 PM**

Chair Kristine Custodio Suero: Meeting was called to order at 12:01 PM.

Agenda item #2 – Approval of Minutes: Vice Chair Gutierrez mentioned on page 2 under public comment "Language of Women Voters" should be changed to "League of Women Voters". Comm. Ogunsaju mentioned that International Women's Day events are usually held in March, so she wanted a point of clarification on the event Ms. Mutual indicated during public comment. The December 2024 meeting minutes reflect May 6th, therefore confirmation on the month would be greatly appreciated and changed if necessary. Motion by Comm. Ogunsaju to approve the December 2024 meeting minutes with the changes mentioned; seconded by Vice Chair Davis. Motion passed with all in favor of the motion.

Agenda item #4 – Committee Reports:

- a. Civic Engagement: Vice Chair Davis to chair the committee.
- b. Policy: Vice Chair Ogunsaju to chair the committee. Comm. Nantkes, former chair of the committee, has helped with the transition of responsibilities and will remain a member of the committee.
- c. Governance: Vice Chair Gutierrez to remain as chair of the committee. Committee did not meet in December 2024. No updates.

Agenda item #5 – Initiative Updates and Liaison Reports

- b. Women's Hall of Fame: Chair Custodio Suero shared that the Executive Director is Laura Mitchell, and they have been in communication via email. Ms. Mitchell informed Chair Custodio Suero that the event is scheduled for Saturday, November 8, 2025. San Diego History Museum is collaborating with Women's Hall of Fame.
- c. ACCW: No updates from Comm. Welty who still has not been able to get a hold of anyone at ACCW. Former Chair Ijadi-Maghsoodi will try to help connect Comm. Welty with someone at ACCW.

Agenda item #6 – Update on proposed by-law changes: Staff Assistant Garcia shared that the proposed bylaws are in the hands of the Finance and General Government Group Executive Office. They are in the process of reviewing the changes and will be creating the board letter recommending the changes be approved by the Board of Supervisors. The bylaw changes and drafted board letter needs to be reviewed by the County Counsel's Office as well as County folk that might have an interest in the board letter, including OERJ. Vice Chair Gutierrez asked if OERJ also reviews the bylaw changes and Staff Assistant Garcia confirmed.

New Business

Agenda item #7 – Guest Speaker: Bilateral Safety Corridor Coalition (Marisa Ugarte): Please see attachment B

Agenda item #8 – Approve 2024 Annual Report: Vice Chair Gutierrez recommended changes to the annual report, including correcting a few formatting issues, adding the Commission logo, and adding funding as a priority for 2025. Comm. Nantkes mentioned she was under the impression that there would be more details regarding the grant to show the extensive work, even if it is an appendix. Vice Chair Davis made a motion that the approval of 2024 Annual Report be tabled for discussion during the February 2025 meeting; seconded by Vice Chair Ogunsaju. Motion passed with all commissioners voting in favor of the motion. Vice Chairs Davis and Gutierrez agreed to make revisions to the 2024 Annual Report prior to the February meeting.

Agenda item #9 – Establish 2025 regular meeting calendar: Executive Committee meeting hosted at 11:30 AM in person on the first Friday of the month. The regular Commission meeting will be held at noon for 1 hour on the first Friday of the month via the hybrid model followed by in person committee meetings at 1PM to 2PM. Vice Chair Ogunjasu mentioned that the Policy Committee will try to find a public location to host their meetings to allow for other commissioners to join as it will not be tied to other committee meeting dates/times. Senior Deputy Murray mentioned that as long as the meeting is publicly noticed and follows the Brown Act, the meetings can be held at any location. Comm. Nantkes mentioned the first Friday in July is a holiday, so the July meeting will be held on July 11th. The regular monthly Commission meetings at the County Administration Center building. The room number might change from month to month depending on availability. Vice Chair Davis made a motion to approve the 2025 regular meeting schedule as mentioned; seconded by Comm. Nantkes. Motion passed with all commissioners voting in favor of the motion.

Agenda item #10 – Outreach Strategies:

- a. Supervisors: Chair Custodio Suero as well as others have already contacted some of the Supervisors regarding vacancies. Each appointee will contact their respective supervisor when there is a vacancy and/or when their term is about to expire.
 - Supervisor Nora Vargas in District 1, has appointed Monica Martinez to the commission. Ms. Martinez was in attendance in person and may attend meetings as a guest until she attends an orientation. The vice chairs will do an onboarding session with Ms. Martinez before the February meeting, and she will also need to complete the additional required trainings.
- b. Internal Connections: Vice Chair Davis wanted to plant the seed of forming connections with the City's Commission on the Status of Women and Girls, The Dept. of Labor, liaison

Agenda item #12 – Commissioner's attendance/presence at public events: Generally, it is not advised that a whole commission or board attend an event because if there is any official business discussed at that event then there is a violation of the Brown Act. If there is not quorum, then most likely there will not be a violation of the Brown Act. If all commissioners want to attend an event, then it is recommended to be very strict on what is

discussed so that no violation of the Brown Act occurs. Everyone can attend the Women's Hall of Fame induction as long as there is no discussion of official business.

CEDAW Advisor Report:

The concerns the Commission has raised regarding the County not adhering to the language or the intent of the ordinance for the mandated baseline data analysis remain. The OERJ has been unwilling or unable to explain its divergence from evidence-based best practices and the concerns raised by the Commission and the Commission's allies, including regional and national entities including Cities for CEDAW. While it may be better in the short-term for the County to avoid revealing inequities in County operations that would otherwise go undetected, doing so hinders actual progress and will impede the Commission's ability to complete the roles set forth in the ordinance, including developing action plans to eradicate the discriminatory practices causing those inequities. We do not want another Project 100. As we shared at the last meeting, the Commission was written into the ordinance for a reason and the Commission's involvement in each stage of CEDAW implementation was accomplished over the objections of the County. As stated in the PowerPoint Commissioner Nantkes and I presented at the last Commission meeting, "The government is already the most powerful institution in developed societies, and it often has the greatest interest in distorting or hiding inconvenient facts. Allowing the government to supervise the search for truth is like appointing the fox to guard the chicken coop." At this point, we will be preparing a detailed letter to the Supervisors and OERJ regarding this. We will share the letter with all Commissioners so that you can continue to meet and to set up meetings with the Supervisors. I, along with Commissioner Nantkes, stand ready and available to support you.



The Definitions

Trafficking Definitions

- Labor Severe form of sex trafficking in which a commercial sex act is induced by means or <u>force,or fraud, or coercion</u>, or in which the person induced to perform such an act has not attained 18 years of age; labor.
- The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of **force or fraud, or coercion** for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

Challenge: Severe? Isn't slavery severe enough?

Understanding force fraud or coercion; everyone working in human trafficking interprets it differently.

2008 Wilberforce

The 2008 reauthorization expanded the protections available with the T visa, and required that all unaccompanied alien children be screened as potential victims of human trafficking. This reauthorization also enhanced criminal sanctions against traffickers, and expanded definitions of various types of trafficking to make prosecution easier.

ILO also released a separate report showing **152 million children** were victims of child labor, which amounted to nearly one in every 10 children worldwide, with almost half of those engaged in hazardous work. More than two-thirds of these children were working on a family farms or in a family business, with 71 percent overall. Including the US working in agriculture



Human Trafficking for a Criminal Enterprise:

Door-to-Door Sales

- Children employed in door-to-door sales may not work during school hours and must be at least 12 years old
 - Cal. Labor Code § 1308.1 provides that no minor under the age of 6 is permitted to engage in door-to-door or street sales
 - However, Cal. Education Code § 49111 provides that Permits to Employ and Permits to Work (required for doorto-door sales) may only be issued with respect to minors who are at least 12 years of age

Minors Under 16

- May not:
 - Sell to passing motorists newspapers, candy, flowers, or other merchandise or commodities from a fixed location on a street, highway, freeway island or divider, freeway on or off ramp, or freeway shoulder
 - Sell newspaper or magazine subscriptions, candy, cookies, flowers, or other merchandise or commodities door-to-door...unless...

Conditions for Door-to-Door Sales by Minors Under 16

- All of the following conditions MUST be met:
 - Minors must work in pairs, as a team, on the same or opposite side of the street;
 - Each crew of 10 or fewer minors must be supervised by an adult;
 - Minors must be within the sight and sound of the adult supervisor at least once every 15 minutes;
 - Minors must be returned to their respective homes daily after work;
 - Sales activities must be performed within 50 miles of the minor's residence
 - Cal. Labor Code §§ 1296 and § 1308.1,
 - 8 Cal. Code of Regulations § 11706

Door-to-Door Sales U.S **Registration Requirements**

- California law requires employers, supervisors and transporters of minors under 16 in door-to-door sales to register with the DLSE if minors are transported more than 10 miles from their home
- Registration is valid for one year from the date of issuance and must be renewed annually
- Form DLSE 453 (Employer, Transporter and Supervisor Application)

Registration Requirements

- Exemptions
 - Any religious corporation / organization which holds property for religious purposes;
 - A bona fide cemetery corporation;
 - A bona fide political committee; or
 - A bona fide charitable corporation / organization operated primarily as a religious organization, éducational institution, hospital, or licensed health care service plan
