Public Comments/Announcements: Members or non-members Chris Maeoka mentioned that Jewish Family Services has a job opportunity for a Dementia Specialist c. Minutes: Record of January 8, 2018 meeting (Action) [M/S – L. Monge / F. Davis: Unanimous] 			
Guest Speaker Presentation	 a. Maria Molina-Melendez, Social Work Supervisor, AIS, IHSS Population served and new regulations being implemented on behalf of IHSS and Public Authority; Purpose helps recipients to remain safely at home and helps with avoidance of institutionalization; IHSS collaborates with Public Authority, which manages Individual Providers; Some requirements of IHSS recipients (not all of them) would be: low income, elderly, blind, disabled required help with daily activities, CA resident in US, live in own home, medical certification There is a new assessment policy called "Person-Centered Services" focusing more on what is currently happening to the senior, the IHSS process, etc., versus the hourly computation of the provider, etc.; IHSS has implemented four Fact Sheets given out during a home visit, in different languages; These Fact Sheets remain in the home for further review by the recipient; helps person-centered service; The Fact Sheets are: Program Services – helps with task assessment Functional Index Ranking Right to File a State Hearing - if dissatisfied with hours Protective Supervision Services – for minor children Presenter then entertained a series of Q&A that followed the PowerPoint presentation. Kathy suggested an IHSS Committee be created to talk about transitioning, care coordination, etc Martha McCarthy reminded that she serves by Chair appointment to the IHSS state-required IHSS Committee.

Age Well Action Status – Last Age Well Planning Meeting (2/14) coming and Chuck thanked those Advisory Council involved for their time, help and influence with the planning meetings. Age Well San Diego action plan will be seen by the Board in May, then sent to AARP for review. Going forward, this is an AARP world health practice and we are making sure we're in alignment with the standards and practices for national Age-Friendly network. c. Other Operational items: AIS is very fortunate to now have Jennifer Bransford-Koons as Assistant Director. d. This JA Training Rm will soon be re-vitalized, technologically speaking. e. Kristen and her team of Age Friendly are going 'gang busters," becoming more technology-friendly and are re-designing the monthly newsletter. 5. Executive Committee (1/22/18) Report/Other Business (possible action)	a. Chair's Report & Comments i. Guest: Gloria Sanchez, TACC President; Riverside AAA, Chair, introduced by Rosemarie as Riverside County's AAA Advisory Council Chair. Rosemarie stated that there are 33 AAAs within CA that represent all CA state counties. TACC = Triple-A Council of California. This February, Lorelei and		
	Rosemarie will be going to Sacramento to represent the AlS Advisory Council. They will be there on Capitol Day and plan to converse with their State Representative.		
	Gloria states her tenure as Chair at Riverside and TACC has been crucial to helping older folks not be forgotten and providing for health and mental health care by being vigilant and involved with the CA Legislators. Their Advisory Council representatives meet with members and seniors regularly for lunch to assess: Senior Nutrition, Medical Services, Transportation, Affordable Housing, and Socialization.		
	Riverside has established a foundation on aging as a pathway to monetary donations to the Office on Aging. This money is given to the agency specifically for the five priorities (above). The foundation sponsors an annual golf tournament and proceeds going to a holiday party raffle produce gift card give-away, allocating a certain number of gift cards per senior center. Participants include corporate sponsors, Board of Supervisors or anyone who would like to donate.		
	TACC budget is waning and is funded through your taxes under Code 400. Rosemarie asked the CSL group what their tax code number would be for deducted support. Was said to be on the CSL website.		
	ii. Age Well Committee Participants per AIS staff request – Kristen was recognized to confirm the Age Well Planning Meeting is scheduled for 1 – 3:30 PM on Wednesday, February 14.		
	iii. Annual Off-Site Meeting, April 9, 2018 A suggestion was made for the venue being the Salvation Army; however, that location may not work, so Rosemarie is asking for other venue suggestions.
