Guest Speaker	Beth Brainerd Hallock, Senior Services Program Manager from Interfaith Community Services, spoke about their Senior Services program. <ul style="list-style-type: none"> • ICS works collaboratively with the Home Safe: Homeless Prevention and Diversion Program which supports at risk APS clients with homelessness prevention services. • ICS has case managers in the field all over San Diego County. Role of ICS is to ensure immediate safety of clients; thorough assessment of client strengths and abilities; create individual care plans for housing stability; in depth case management; address barriers such as income levels, abuse; housing navigation; facilitate moves; and ensure ongoing stability by connecting clients with local resources. • Housing and homelessness is getting worse and SD County needs more programs like Home Safe. Clients are focused now on finding a place to age in place rather than just needing support to age in place.
