

# Getting to Know BHSA



## IDENTIFYING KEY POINTS:

- Part of Proposition 1: Passed by CA voters in March 2024
- Modernizes the Mental Health Services Act (MHSA) passed by CA voters in 2004
- Reforms how revenue is allocated from millionaires' 1% tax for counties across state for behavioral health programs/services
  - **No additional funding introduced, but brings new components, requirements, and restrictions**
- Takes effect July 1, 2026 & Lasts for 3 years (Integrated Plan = IP)

### Behavioral Health Services Act

The Behavioral Health Services Act, also known as BHSA, is a state law passed by voters in March 2024. BHSA updates the [Mental Health Services Act \(MHSA\)](#) by:

- Expanding service access to include treatment for people with substance use disorders,
- Prioritizing care for people with the most serious mental illness,
- Providing ongoing resources for housing and workforce development, and
- Continuing investments in prevention, early intervention, and innovative behavioral health pilot programs.

BHSA aims to close service gaps and ensure equitable access to quality care across the state. New BHSA requirements will also enhance oversight, transparency, and accountability at the state and local levels. BHSA includes many changes that will impact contracted programs across San Diego County. For more information on changes to contracted programs, visit the [BHS Service Network Changes webpage](#).



# More About BHSA



- Broadens scope of funding to include standalone **substance use disorder (SUD)** treatment services and housing interventions
- Mandates data-driven reporting and population-level **outcome tracking**
  - Statewide Behavioral Health Goals<sup>NEW</sup>
  - Behavioral Health Outcomes, Accountability, and Transparency Report (BHOATR)<sup>NEW</sup>
- Expands expectations for **collaboration** with Medi-Cal Managed Care Plans (MCPs), schools, public safety, healthcare systems, and tribal and community partners
  - Increased stakeholder engagement (approx. three-fold increase)
- Elevates expectations for **health equity**, parity, access, and identification of community-defined needs, especially for priority populations





# Community Planning Process (CPP)



- BHS conducted engagement and education activities from Spring 2025 to Winter 2026
  - Activities included **input sessions, focus groups, interviews, tabling exchanges** at outreach events, as well as informational BHSA workshops and general presentations
  - Across **86 engagements**, over **1500 individuals** were reached representing all 29 stakeholder groups
  - Almost 300 unique organizations & programs
  - Contractor support included
  - Intention to come back on annual basis

**Summary of Engagement Activity**

On May 1, 2025, the County of San Diego Behavioral Health Services (BHS), in collaboration with the University of California, San Diego (UCSD) Health Partnership, hosted a listening session during the BHS Housing Council Retreat at the San Diego County Housing and Community Development Services (HCDS) building. The Housing Council provides guidance on the design, implementation, and evaluation of housing interventions to address the behavioral health needs of individuals at risk of or experiencing homelessness or housing insecurity. This session was designed to gather early input to inform the development of the County's first Behavioral Health Services Act (BHSA) Integrated Plan and input session questions were formulated based on prior input and work of the Council, including the 2022-2027 Strategic Housing Plan.



## • Gaps in Behavioral Health Data and Analysis

Participants expressed behavioral health data is misrepresented or only telling part of the story, as the data shared is believed to be overly crisis-focused and lacking in cultural/regional context.

## • Workforce Mental Health and Readiness

Participants highlighted the need to examine mental health challenges within the workforce and explore linkages between school-based supports (such as IEPs) and readiness for employment.

## • Access and Equity Barriers Prevent Community Members from Seeking Care

Stigma was identified by participants as a major barrier related to seeking out and receiving behavioral health care. Community members also voiced challenges in receiving care in a timely manner, with contributing factors of mistrust in institutions, lack of transportation, language barriers, and costs.

## • Desire to Learn how Environmental Factors Correlate to Behavioral Health

The audience expressed a desire for more education about how educational factors such as housing instability, socioeconomic hardship, and COVID-19's lasting impact influence behavioral health data sets.

- Expand Culturally Appropriate Behavioral Health Interventions**  
 Participants shared the need to build trust and cultural relevance into all behavioral health programs.
- Strengthen Key Communication Partnerships**  
 Improve early detection by working with trusted programs, schools, parents, and caregivers to spot behavioral health needs sooner.
- Focus Data to Subregional Approach**  
 Use data-driven, prevention-focused strategies whenever possible to divide the region into smaller subgroups or subregions and align interventions with the specific needs of each group.
- Advance Workforce Mental Health Initiatives**  
 Explore programs that address mental health challenges in workplace settings and strengthen linkages between school-based supports and workforce readiness.
- Enhance Substance Use Monitoring and Communication**  
 Improve classification and reporting of overdose and substance-related incidents, reconcile perceived fentanyl trends with data, and include clear explanatory notes in future presentations.
- Additional Goals: Engagement in Schools and Social Connections**  
 The audience identified "Engagement in Schools" and "Social Connections as additional goals."



- **30-Day Public Comment Period**

- California law (Welfare and Institutions Code, or WIC) requires counties to ask the public for input before submittal of their finalized BHSA IP to the Department of Health Care Services (DHCS).
- During baseline years, every county must host a **30-Day Public Comment Period**, during which people may read the draft plan and share their thoughts in writing — what they like, questions they may have, recommended changes, etc.
- If a county elicits participation from stakeholders for an Annual or Intermittent Update to their IP, they must fulfill this Public Comment Period requirement prior to the effective date of the updates.

- **Public Hearing**

- Every counties' behavioral health board/commission shall conduct a public hearing following a 30-Day Public Comment Period. The **Public Hearing for San Diego County's 2026-2029 BHSA IP draft** is scheduled for the BHAB's **05/07/2026** convening.
- At this convening, stakeholders may share opinions with BHS leadership in-person or online and react to others' comments. The department will document and summarize feedback and revise the IP before presenting it to the San Diego County Board of Supervisors for final approval and DHCS submittal.
