CSOC Council Vision: San Diego youth are healthy, safe, successful in school, and in their transition to adulthood, while being law abiding, while living in a home and community that supports strong family connections.

Mission: The purpose of the System of Care Council is to ensure that all agencies serving San Diego county youth from age 0 through age 21 have coordinated services resulting in improved youth and family, and system outcomes consistent with System of Care Values and Principles.

1. **Collaboration of four sectors:** The cornerstone of the CSOC is a strong four sectors partnership between youth/families, public agencies, private organizations and education that ensure accountability to achieve System of Care (SOC) goals and quality outcomes consistent with SOC philosophy.
2. **Integrated:** Among the four sector partners services are comprehensive, accessible coordinate behavioral and physical health care, provide seamless transition of care and utilize natural community supports,
3. **Youth guided, family driven:** Youth and families actively participate in service delivery, planning, and program and policy development.
4. **Individualized:** Services are flexible and designed to meet and build upon the unique needs, strengths and potential of each youth, and family.
5. **Strength-based:** Individualized plans and services identify and utilize youth/family strengths to facilitate health and wellness.
6. **Community-based:** Sector partners offer an array of services in each region and strengthen family and youth connections to neighborhood and local community resources.
7. **Outcome driven:** Service delivery systems continuously improve services by measuring and evaluating outcomes and use results to modify practices.
8. **Culturally Competent:** Service providers honor the diversity of cultures; address the complexities within and between cultures, and provide accessible and relevant services.
9. **Trauma Informed:** Sector partners recognize that trauma and chronic stress influence coping strategies and behavior, respond with compassion, and commit to the prevention of re-traumatization and the promotion of self-care and resilience.

I. Welcome and Introductions (Delrena Swaggerty)

- Eileen Quinn-O'Malley and Shannon Jackson were welcomed as the two new Behavioral Health Program Coordinators in the Children, Youth and Families team.

II. Approval of Minutes- June 13, 2016 and July 11, 2016 (Renee Cookson)

III. Director's Report (Alfredo Aguirre)

Alfredo Aguirre provided an opportunity to the meeting attendees to reflect on the recent presidential election results and share:

- ✓ The reactions from clients and staff received and how these reactions are being addressed in their programs.
- ✓ Concerns due to the potential impacts in the current behavioral health system.

Summary of the meeting attendees responses:

- In the Education sector, distress, fear, and disappointment has been observed and the sector has been offering support by providing nurturing conversations.
- The family sector has been observing increased stress in the households and would like to increase conversations with parents. Families have been reaching out to the Faith community for support.
- The private sector shared that they are engaging clients in conversations to allow them to share their concerns and recognized that San Diego is prepared to address behavioral health needs in times of uncertainty.
- The local Federal Qualified Health Centers (FQHC) are also experiencing anxiety and having discussions with Behavioral Health consultants in preparation for potential changes.
- Alfredo Aguirre added that all of the waivers could be discontinued, and that other sources of funding could be discontinued. In anticipation, the County Behavioral Health Directors Association of California (CBHDA) is working on a coordinated approach with lobbyists.
- The approval of Adult Use of Marijuana Act (Proposition 64) in the November 8, 2016 election is an area of concern and will be used as an opportunity to provide more education related to drug use.

As the Community Engagement forums ended, the MHSA team is working on MHSA Three-Year Program and Expenditure Plan. It is expected to be available for review in the spring of 2017.

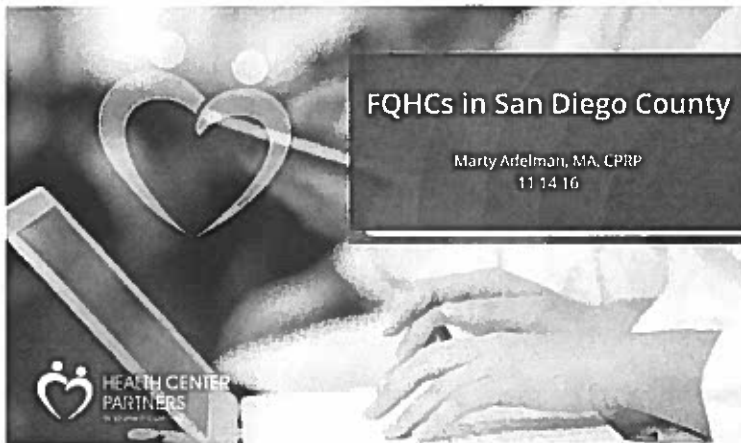

FQHC: A definition or two

A **Federally Qualified Health Center (FQHC)** is a Community Health Center (CHC) which has received a reimbursement designation from the Bureau of Primary Health Care and the Centers for Medicare and Medicaid Services of the United States Department of Health and Human Services.

An FQHC is a primary care center that is community-based and patient-directed. By mission and design, FQHCs exist to serve those who have limited access to health care, i.e. the "safety net", although all are welcome.

All have primary care, preventative care, care for chronic diseases

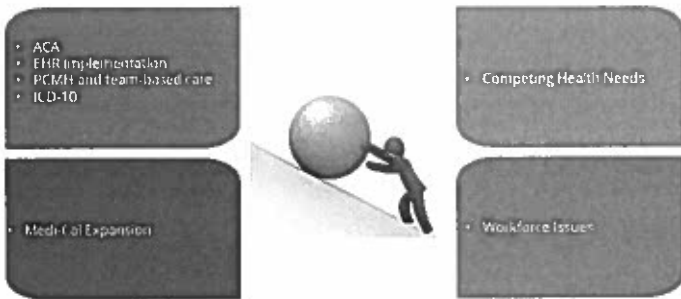

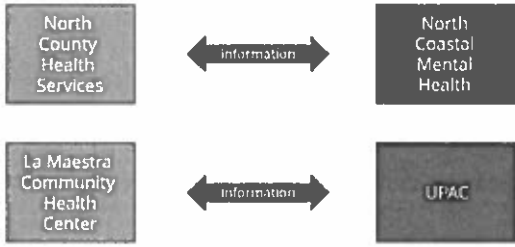

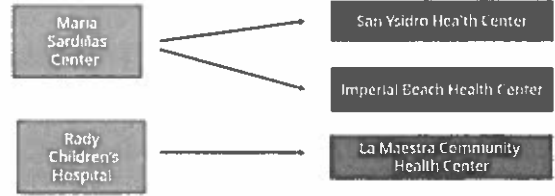

**Sub-Committee Update Report to CYFBHSOC Council
December 12, 2016**

Sub-committee: Early Childhood Mental Health
Lead: Aisha Pope and Stacey Annand (Co-chairs)

Update

- The We Can't Wait Conference took place in September 2016 and was well attended. Attendee feedback was very positive and planning for 2017 is underway.
- ECMH sub-committee has invited the Pathways unit (to our December meeting) to discuss eligibility criteria and best practices for children ages 0-5 as related to Pathways to Wellbeing.
- Committee members continue to promote and participate in relevant trainings that encourage the most up-to-date clinical standards of practice for ages 0-5 and their families (i.e.: most recently, the newly revised 0-5 BHA 2-day training—In January: TFCBT advanced training for 0-5; and, the Reflective Parenting Program)

- CWS is piloting a State required outcome measure TOP (Treatment Outcome Package) with 150 youth. The pilot started on 10/10/16 and will occur for 6 months. BHS Clinicians (in mental health treatment contracts) who work with youth in the pilot will be asked by CWS to complete the TOP Clinical Scale Form.
- Committee continues to follow up on the State POS plan. County sent Provider Rep (CRF) to a one time planning meeting in Sacramento in July 2016. The State POS plan continues to be in the planning phase.
- SAMHSA's definition of Trauma has been inserted as a Help Text in the BHA. Announced in the October 2016 QI Up to The Minute newsletter.
- Literature reviewed of prevalence rate of trauma. Summary sheet from CASRC will be provided to CYFBHSOC.
